

ORDINANCE NO. 125

AN ORDINANCE, annexing portions of Sections 21 and 28 to the City of Bellevue upon the petition of the owners of at least 75% in value of the said property hereby annexed.

WHEREAS, a written petition was filed with the City Council of the City of Bellevue for the annexation of the territory herein described; and

WHEREAS, the City council has examined the petition and has found upon satisfactory proof that the petition was signed by the owners of not less than 75% in value, according to the assessed valuation for general taxation of the property therein described, and in all respects has met the requirements of Chapter 128, Laws of 1945 of the State of Washington; and

WHEREAS, the City Council fixed the 30th day of August, 1955, as the date for public hearing thereon and caused notice of such hearing to be published in accordance with the law, and the hearing having been held on that date and continued to the 27th day of September, 1955, and again continued to and concluded on the 1st day of November, 1955, now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. That the proposed annexation of territory to the City of Bellevue will be conducive to the public health, welfare and convenience of the City of Bellevue and will be of special benefit to the land included within the boundaries of the territory proposed to be annexed.


Section 2. That the boundaries of the territory to be annexed to the City of Bellevue are hereby described as follows:


"Beginning at a point on the north line of Section 21, Twp. 25, R. 5 E. W. M., King County, Washington, which point is 1270.3 feet east of the northwest corner of said Section, thence south to the center line intersection of N. E. 28th Street and 120th Avenue, N. E., thence following the center line of 120th Avenue N. E. until the same intersects with the Bellevue city limits, thence south-easterly along the Bellevue city limits until the same intersects the north and south center line of Section 28 of said Township and Range, thence north along the north and south center line of said Sections 28 and 21, until the same intersects the east and west center line of said Section 21, thence east 657.79 feet, thence north to the north line of said Section 21, thence west to the point of beginning"


Section 3. That the above described territory shall become a part of the City of Bellevue on the 10th day of November, 1955, and become subject to all of its laws and ordinances then and thereafter in force.

Section 4. That copies of this ordinance shall be filed with the Board of County Commissioners of King County, Washington.




