

ORDINANCE NO. 133

AN ORDINANCE, Repealing Ordinances No. 74, 82, 87, 108 and 118; re-establishing salaries and other rates of compensation of City Employees.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Ordinances No. ~~74~~ 82, 87, 108 and 118, establishing rates of compensation of city employees are repealed.

Section 2. The administrative and legislative officers, agents and employees of the City of Bellevue hereinafter listed shall be compensated for services rendered to the City of Bellevue, after the 31st day of December, 1955, at the salary, wage or compensation set forth opposite the respective business classification, to-wit:
