ORDINANCE NO. 133

AN ORDINANCE, Repealing Ordinances No. 74, 82, 87, 108 and 118; re-establishing salaries and other rates of compensation of City Employees.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:
