

ORDINANCE NO. 142

AN ORDINANCE, amending Section 2.10 of Ordinance No. 68, adding thereto Paragraph 2.10.15; reclassifying property between 112th Avenue N.E., and S. E., to 116th Avenue N.E., and S. E., and N. E. 10th Street to S. E. 8th Street from R-A and C-1 to B-2.

WHEREAS, application for a reclassification of the parcel hereinafter described was duly filed with the appropriate City official; and

WHEREAS, investigation was made by the City Planning Commission and a public hearing was had thereon before the Planning Commission upon notice to all interested persons, and

WHEREAS, the Planning Commission has determined that the public use and interest will be served by granting of the proposed changes and has recommended the reclassification of the same to the City Council; and

WHEREAS, the Council has heard and considered the petition together with opinions and recommendations of the Planning Commission; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 2.10 of Ordinance No. 68 is amended to the extent that the same is inconsistent with Paragraph 2.10.15.

Section 2. Section 2.10 of Ordinance No. 68 is amended by adding thereto a new Paragraph 2.10.15, which Paragraph shall provide as follows:

"2.10.15. The use classification of the following described property within the City of Bellevue, to-wit:

Commencing at the intersection of the center lines of 112th Avenue N. E., and N. E. 10th Street; thence east along the center line of N. E. 10th Street to the intersection thereof with the center line of 116th Avenue N. E., thence south along said center line of 116th Avenue N. E., and 116th Avenue S. E., to the intersection thereof with the center line of S. E. 8th Street; thence westerly along said center line of S. E. 8th Street to the center line of 112th S. E.; thence northerly along the center line of 112th Avenue S. E., and 112th Avenue N. E., to the point of beginning.

be, and the same hereby is, changed from R-A and C-1 to B-2."

Section 3. This Ordinance shall take effect and be in force ~~five (5)~~ ^{on} ~~days~~ after ~~its passage~~, approval and legal publication.
