

ORDINANCE NO. 206

AN ORDINANCE relating to salaries, amending Ordinance No. 183.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 183 is amended to provide as follows:

"The administrative and legislative officers, agents and employees of the City of Bellevue hereinafter listed shall be compensated for services rendered to the City of Bellevue after the 30th day of June, 1957, at the salary, wage or compensation set forth opposite the respective business classifications, to-wit:
