

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 2092

AN ORDINANCE establishing a Department of Finance and designating the Director thereof as City Treasurer; adding new sections 3.37.010, 3.37.020, 3.37.030, 3.37.040, 3.37.050; repealing Sections 1, 2, 3 and 4 of Ordinance No. 9 and Chapter 3.12 of the Bellevue City Code which established the office of the City Treasurer.

THE CITY COUNCIL OF THE CITY OF BELLEUVE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The following new sections are hereby added to chapter 3.37 of the Bellevue City Code:

CHAPTER 3.37

Department of Finance

3.37.010 Department established--Function. There is hereby established a Department of Finance which shall be responsible for general supervision over the financial affairs of the City of Bellevue.

3.37.020 Appointment of Director. The functions of the Department shall be executed under the supervision and control of a Director of Finance. The Director shall be appointed for an indefinite term by the City Manager for his/her executive and administrative qualifications in such work. The Director may be removed by the City Manager at any time subject to any civil service regulation adopted by the Council and then in force.

3.37.030 Designator as City Treasurer. The Director of Finance shall be designated City Treasurer to perform in such capacity whenever the laws of the State of Washington or the ordinances of the City of Bellevue make reference to such position.

The Director of Finance may appoint a subordinate employee from the Department of Finance to assist in the performance of the duties of City Treasurer.

3.37.040 Bond. Before undertaking the duties of City Treasurer, the Director shall qualify by furnishing a fidelity bond at the expense of the city in a sum to be set by the City Council.


3.37.050 Powers and Duties. The Director of Finance shall have powers and duties coextensive with those prescribed by the laws of the State of Washington and the ordinances of the City of Bellevue as now in force or as hereinafter amended or adopted.

Section 2. Ordinance No. 9, sections 1, 2, 3 and 4 and Chapter 3.12 of the Bellevue City Code are hereby repealed.


Section 3. This ordinance shall take effect and be in force five days after its passage, approval and legal publication.


