ORDINANCE NO. 2204

AN ORDINANCE determining the public advantage in vacating the portion of Northeast 32nd Street at 100th Northeast within the City of Bellevue.

WHEREAS, the City Council did on the third day of March, 1975, pass Resolution No. 2484 fixing the time and place for a hearing to consider the petition of Robert C. Koch, Gladys Gallup Koch, Joseph J. Mulligan, Nancy M. Mulligan, Wendall R. Brockett and Edna L. Brockett for the vacation of a portion of Northeast 32nd Street at 100th Northeast within the City of Bellevue, said petitioners the owners of more than 2/3 of the land abutting the area proposed for vacation and gave notice of said hearing by posting and mailing in the manner required by law; and

WHEREAS, investigation was made as to the use of said street and the public interest to be served or damaged by a change of use or vacation thereof; and

WHEREAS, a hearing was held upon the said petition on the 31st day of March, 1975, at the time and place fixed in said resolution and notice, and as a result thereof, the City Council having found that the vacation of said street to the extent described in the petition therefore would serve the public good; and no objections thereto being made by the owners of private abutting property; now, therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The following portion of Northeast 32nd Street at 100th Northeast within the City of Bellevue, to wit:

From a point beginning at NE corner of Lot 1, Block 1, second addition to Summit Place, to NW corner of Lot 1, Block 1, second addition to Summit Place, to SW corner of Lot 10, Lake Washington Spring Hills Division No. 2, to a point 30 feet west of SE corner of Lot 10, Lake Washington Spring Hills Division No. 2, to the beginning point at NE corner of Lot 1, Block 1, second addition to Summit Place excepting therefrom the easterly 25 feet


is vacated: reserving easements for the construction use and maintenance of wires, lines, underground pipes and any or all appurtenances which may be required by public utilities within such vacated portions.

Section 2. The administration is hereby directed to record a certified copy of this ordinance with the records department of King County.


Section 3. This ordinance shall take effect and be in force five days after its passage, approval and legal publication.
