

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO 2272

AN ORDINANCE adopting a budget for the City of Bellevue, Washington, for the year 1976, setting forth the estimated revenues and appropriations and repealing certain Ordinances classifying City employees.

WHEREAS, a preliminary budget has been filed with the City Clerk as required by law; and

WHEREAS, a public hearing was held by the Council upon notice at which time comments for or against any part of the budget were heard; and

WHEREAS, the Council has made such adjustments and changes as it deemed necessary or proper; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The budget of the City of Bellevue, Washington, for the year 1976, a copy of which has been given Clerk's Receiving No. 3498, is hereby adopted in the aggregate amount of \$26,802,704.00.

Section 5. The Clerk is directed to transmit a certified copy of this ordinance to the Office of the Auditor of the State of Washington, Division of Municipal Corporations.


Section 6. This ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.


