156th Ave. NE from NE 8th St. to NE 16th St.
NE 8th St. from 156th Ave. NE to 164th Ave. NE.
NE 20th St. from 136th Ave. NE to 156th Ave. NE.
The Bellevue-Redmond Rd. from NE 20th St. to 156th Ave. NE.
148th Ave. NE from 16th St. to NE 24th St.
SE 32nd St. from 139th Ave. SE to 156th Ave. SE.
Main St. from 140th Ave. to 151st Ave.

Section 2. This ordinance is hereby declared to be an emergency ordinance necessary for the protection of the public health, public safety, public property and public peace, and shall be effective upon passage by a majority plus one of the whole membership of the City
