

BELLEVUE CITY ORDINANCE NO. 232

AN ORDINANCE, amending Section 2.10 of Ordinance No. 68, adding thereto Paragraph 2.10.23; reclassifying a portion of the southwest quarter of the northeast quarter of Section 32, Township 25 North, Range 5 East, W.M., from R-10 to R-S.

WHEREAS, application for a reclassification of the parcel hereinafter described was duly filed with the appropriate City official; and

WHEREAS, investigation was made by the City Planning Commission and a public hearing was had thereon before the Planning Commission upon notice to all interested persons; and

WHEREAS, the Planning Commission has determined that the public use and interest will be served by granting of the proposed changes and has recommended the reclassification of the same to the City Council; and

WHEREAS, the Council has heard and considered the petition together with opinions and recommendations of the Planning Commission; now therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 2.10 of Ordinance No. 68 is amended to the extent that the same is inconsistent with Paragraph 2.10.23.

Section 2. Section 2.10 of Ordinance No. 68 is amended by adding thereto a new Paragraph 2.10.23, which paragraph shall provide as follows:

"2.10.23. The use classification of the following described property within the City of Bellevue, to-wit:

East 120 feet of the West 150 feet of the South 82.5 feet of the North half of the southwest quarter of the northeast quarter and the North 16.5 feet of the East 120 feet of the West 150 feet of the South half of the southwest quarter of the northeast quarter, all in Sec. 32, Township 25 N, Range 5 East W.M. ALSO North 82.5 feet of the West quarter of the South half of the southwest quarter of the northeast quarter and the South 82.5 feet of the West three-quarters of the North half of the southwest quarter of the northeast quarter all in Sec. 32, Township 25 N, Range 5 East W.M. except the West 150 feet thereof and except the East 647.66 feet thereof,

be, and the same hereby is, changed from R-10 to R-S."

Section 3. This Ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.
