ORDINANCE NO. 2355

AN ORDINANCE adding a definition of family day care homes and revising the permit requirements for such homes in single family residence districts in the Bellevue Zoning Code, amending Ordinances 1282 and 2281, Section 3, and amending Sections 18.05.030 and 18.08.132 of the Bellevue Zoning Code.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Ordinance 1282 and the Bellevue Zoning Code Section 18.05.030 are each hereby amended to read as follows:

18.05.030 ADDITIONAL DEFINITIONS:

- DWELLING, ONE-FAMILY. A detached building containing but one kitchen, designed for and occupied exclusively by one family and the household employees of that family.
- DWELLING, DUPLEX. A building containing two kitchens and designed to be occupied by two families living independently of each other.
- DWELLING, MULTIFAMILY. A building designed to house two or more families living independently of each other.
- DWELLING UNIT. A building or portion thereof providing complete housekeeping facilities for one family.
- ELECTRICAL DISTRIBUTION SUBSTATION. An assembly of equipment designed to receive energy from a high voltage distribution supply system to convert it to a form suitable for local distribution and to distribute the energy to feeders through switching equipment designed to protect the service from the effects of faults.
- ESSENTIAL USE. That use for the preservation or promotion of which the use district was created, and to which all other permitted uses are subordinate.
- FAMILY. One person or two or more related persons living together. Not more than eight unrelated persons living together as a single, nonprofit housekeeping unit or not more than ten unrelated persons living together in a State of Washington licensed group home.

FAMILY DAY CARE HOME. A facility that is defined as such in the Washington Administrative Code (WAC) 388-75-015(6) (c), as now or hereafter amended.

Section 2. Ordinance 1282, Ordinance 2281, Section 3 and the Bellevue Zoning Code, Section 18.08.132 are each hereby amended to read as follows:

18.08.132 PERMITS FOR STATE-LICENSED FAMILY DAY CARE HOMES. A permit for the performance of services in the applicant's private home in connection with day care of children or infants may be granted upon a finding and a showing that the home and the applicant are duly licensed by the State Department of SOCIAL AND HEALTH SERVICES, or its successor, for operation as a licensed family day-care home in accordance with standards promulgated by said department. The permits herein provided for shall become void upon the termination, revocation or suspension of such license by the said state department. The procedures contained in sections 18.08.133 and 18.08.134 shall apply to the permits provided for in this section.

Section 3. This ordinance will take effect and be in force 30 days after enactment by the Council.
