CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 2427

AN ORDINANCE amending Ordinance No. 2090s1 (part) and Section 9.10.020N of the Bellevue City Code to facilitate City enforcement of nuisance ordinance against unsightly accumulations of unused vehicles.

WHEREAS, the City has received numerous complaints regarding accumulations of unused automobile and automobile parts in various residential areas of the City; and

WHEREAS, current wording of the City nuisance ordinance hinders enforcement thereof against such accumulations; and

WHEREAS, a minor amendment of the language of the relevant subsection may permit needed enforcement without a separate ordinance relating solely to vehicle accumulations, NOW, THEREFORE

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Section 1 (part) of Ordinance No. 2090 and Bellevue City Code Section 9.10.020N are each hereby amended to read as follows:

9.10.020 Types of nuisances.

Each of the following conditions, unless otherwise permitted by law, is declared to constitute a public nuisance, and whenever the enforcement officer determines that any of these conditions exist upon any premises or in any lake, river, stream, drainage way or wetlands, the officer may require or provide for abatement thereof pursuant to this chapter:

N. The existence or maintenance on any premises of a storage area, junk yard or dumping ground for the wrecking or disassembling of automobiles, trucks, trailers, housetrailers, boats, tractors or other vehicle or machinery of any kind, or for the storing or leaving of worn out, wrecked, inoperative or abandoned automobiles, trucks, trailers, housetrailers, boats, tractors or other vehicle or machinery of any kind or of any major parts thereof;
