BELLEVUE CITY ORDINANCE NO. 243

AN ORDINANCE amending Ordinance No. 27, known as the Traffic Ordinance, by amending Chapters 12 and 17, by adding thereto new sections relating to operator, dealer, and vehicle licenses; parking of vehicles; vehicle equipment; vehicle size; safety; rules of road; driving delinquencies; and enforcement.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Chapter 12 of Ordinance No. 27, adopted by the City of Bellevue on the 7th day of July, 1953, is amended by adding thereto a Section 128 which shall provide as follows:

"Section 128. Leaving keys in ignition. It is unlawful to stand or park a motor vehicle, unattended, upon a public street or highway without first locking the ignition, removing the key therefrom and keeping such key removed while the vehicle is unattended."

Section 2. Section 171, Chapter 17, of Ordinance No. 27, adopted by the City of Bellevue on the 7th day of July, 1953, is amended to read as follows:
