ORDINANCE NO. 25

AN ORDINANCE amending Section 3 of Ordinance No. 2 re-establishing fire zones within the City of Bellevue.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 3 of Ordinance No. 2 passed by the City Council on the 7th day of April, 1953, is amended by repealing Section 1604-B of the Uniform Building Code, and providing a new section designated Section 1604-C of the Uniform Building Code, establishing fire zones as follows:

All areas within the City of Bellevue lying within the following described boundaries, to-wit:

Beginning at a point 180 feet South and East of the intersection of Main Street and 104th Avenue; thence North on a line parallel with the center line of 104th Ave. N.E. to a point 180 feet East of the intersection of 104th Ave.

N.E. with the center line of N.E. 10th Street; thence West on the center line of N.E. 10th Street extended to a point 180 feet West of the intersection of the center line of N.E. 10th Street and the center line of 104th Ave. N.E.; thence South on a line parallel with the center line of 104th Ave. N.E. to a point 330 feet North of the center line of N.E. 8th St.; thence Westerly on a line parallel with the center line of N.E. 8th Street to the intersection thereof with the center line of 100th Ave. N.E.; thence Southerly along the center line of 100th Ave. N.E. to the intersection of the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 4th Street; thence Easterly along the center line of N.E. 5th Street; thence Southerly on a line parallel to the center line of 104th Ave. N.E.; thence Southerly on a line parallel to the center line of 102nd Ave. N.E.; thence South on a line parallel with the center line of 102nd Ave. N.E. to a point 180 feet South of the center line of Main Street; thence East on a line parallel to the center line of Main Street; thence East on a line parallel to the center line of Main Street; thence East on a line parallel to the center line of Main Street; thence East on a line parallel to the center line of Main Street; thence East on a line parallel to the center line of Main Street; thence East on a line parallel to the center line of Main Street;

shall be declared as Fire Zone 1. All remaining areas within the City of Bellevue are declared to be Fire Zone 3.

Section 2. This ordinance shall take effect and be in force five days after its passage, approval, and publication.
