

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 300

AN ORDINANCE amending Ordinance No. 27, as amended by Ordinances Nos. 47, 72 and 196; providing speed limits and proclaiming arterials.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 43 of Ordinance No. 27 passed by the City Council on July 7, 1953, as amended by Ordinance No. 47 passed December 8, 1953, Ordinance No. 72 passed October 12, 1954, and Ordinance No. 196 passed May 14, 1957, is hereby amended to read as follows:

"Section 43a. Regulation of speed by establishing speed limits. The speed limits on all streets shall be 25 miles per hour except (a) those posted as school zones within which the speed limit shall be 20 miles per hour, and (b) the following named streets on which the speed limit shall be as follows:

"Section 43b. N.E. Lake Washington Blvd., from N.E. 10th to 100th--30 mph;
Main Street, from 100th to 116th--30 mph;
N.E. 8th, from N.E. 1st to Bellevue-Redmond Rd--30 mph;

"Section 43c. Bellevue-Redmond Rd, from 132nd N.E. to N.E. 8th--40 mph;
104th N.E., from north City Limits to Main St.--30 mph;
104th S.E., from Main St. to S.E. 8th--30 mph;

"Section 43d. S.E. Lake Washington Blvd., from 104th S.E. to 107th S.E.--30 mph;
108th S.E., from S.E. 34th to juncture with 107th S.E.--30 mph;
107th S.E., from juncture with 108th S.E. to S.E. Lake Washington Blvd.--30 mph;

"Section 43e. 116th Ave. N.E., from Northrup Road to Main St.--30 mph;
116th Ave. S.E., from Main St. to S.E. 8th--30 mph;
Points Drive from 98th N.E. to 104th N.E.--30 mph;

"Section 43f. S.E. Lake Washington Blvd., from U.S. Highway No. 10 south to south City Limits--30 mph;
Northrup Way, from 132nd Ave. N.E. to 104th Ave. N.E.--35 mph;
Lake Washington Blvd., from 107th S.E. to S.E. 34th St.--40 mph."

Section 2. Section 182 of Ordinance No. 27, as amended by Ordinance Nos. 47 and 72, is hereby amended to read as follows:

"Section 182a. Arterial Highways. In accordance with the provisions of Sec. 72 and when signs are erected giving notice thereof, operators of vehicles shall stop at every intersection before entering any of the following streets or parts of streets:

Main Street, from 100th Avenue N.E. to 116th Avenue N.E., except at the light at 104th Avenue N.E.
Lake Washington Boulevard, from Main Street to the City Limits at N.E. 10th Street.

"Section 182b. Lake Washington Boulevard from 104th Avenue S.E. to S.E. 34th Street.
104th Avenue S.E., from Main Street to S.E. 27th Street, except northbound traffic at Lake Washington Boulevard.
104th Avenue N.E., from Main Street to North City Limits, except at the light at N.E. 8th Street.
108th Avenue N.E., from Main Street to N.E. 24th Street, except at N.E. 8th Street.

"Section 182c. 108th Avenue S.E., from Main Street to S.E. 34th Street, except at Lake Washington Boulevard and 107th N.E.
100th Avenue N.E., from Main Street to N.E. 24th Street, except at N.E. 8th Street.
116th Avenue, from South City Limits to Northrup Way, except at N.E. 8th Street.
N.E. 8th Street, from junction with Bellevue-Redmond Highway to its junction with N.E. 1st Street, except at traffic light at 104th Avenue N.E.

"Section 182d. N.E. 1st Street, from 104th Avenue N.E. to N.E. 10th Street, except at 100th Avenue N.E. and its junction with N.E. 8th Street.
N.E. 4th Street, from 108th Avenue N.E. to 98th Avenue N.E., except at 104th Avenue N.E.
N.E. 5th Street, from 100th Avenue N.E. to N.E. 8th Street.
N.E. 24th Street, from 108th Avenue N.E. to 98th Avenue N.E., except at 104th Avenue N.E.

"Section 182e. S.E. 34th Street, from Lake Washington Boulevard to 108th Avenue S.E.
Northrup Way, from 132nd Avenue N.E. to 104th Avenue N.E.
Bellevue-Redmond Road, from 132nd Avenue N.E. to N.E. 8th Street.
107th Avenue S.E. except for north bound traffic at the intersection with Lake Washington Boulevard.

"Section 182f. 92nd Avenue N.E. from N.E. 8th Street to north City Limits.
S.E. Lake Washington Boulevard from U.S. Highway No. 10 to south City Limits."

Section 3. This Ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.
