## CITY OF BELLEVUE, WASHINGTON

## ORDINANCE NO. 3059

AN ORDINANCE regarding fees under the Electrical Code; and amending Bellevue City Code 23.30.250(B).

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 2233, Sections 6 and 7 (part); and Bellevue City Code 23.30.250(B) are amended to read as follows:

23.30.250 Fees.

...B. Electrical Permit Fee. A permit fee shall be determined by the cost of each job as follows:

Fees for all permits other than for one and two family dwelling units:

- 1. Where the contract cost is \$250 or less: \$20.00
- 2. Where the contract cost is \$251 to \$1,000: \$20.00 plus 3% of cost over \$250.
- 3. Where the contract cost is \$1,001 to \$5,000: \$42.00 plus 1.5% of cost over \$1,000.
- 4. Where the contract cost is \$5,001 to \$50,000: \$102.00 plus 1% of cost over \$5,000.
- 5. Where the contract cost is \$50,001 to \$250,000: \$552.00 plus .8% of cost over \$50,000.
- 6. Where the contract cost is \$250,001 to \$1 million: \$2,152.00 plus .6% of cost over \$250,000.
- 7. Where the contract cost is \$1,000,001 and above: \$6,652.00 plus .4% of cost over \$1 million.
- 8. Swimming pools require a separate permit: \$25.00.

The fee for single and duplex occupancies shall be:

The fee for service changes and remodeling, residential only, shall be:

Service Charge, 100 amp to 200 amp: \$10.00, plus \$.50 per circuit pick up and \$1.00 for each new circuit.

Service Charge, 200 amp to 600 amp: \$35.00, plus \$.50 per circuit pick up and \$1.00 for each new circuit.

Fees for temporary service on construction sites shall be as follows:

<u>Size</u>	<u>Fee</u>
1 to 125A	\$ 31.50
126 to 200A	45.00
201 to 300A	59.00
301 to 400A	80.00
401 to 500A	93.00
501 to 599A	111.00

Section 2. This ordinance shall be published by posting in the three official posting places of the City, and shall take effect and be in force five days after the date of posting.
