

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 324

AN ORDINANCE re-establishing salaries, and amending Ordinance No. 276, as amended by Ordinances No. 283, 298 and 308.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 276, passed by the City Council on December 23, 1958, as amended by Ordinance No. 283 passed January 27, 1959, is hereby amended to read as follows:

"Section 2. The administrative and legislative officers, agents and employees of the City of Bellevue hereinafter listed shall be compensated for services rendered to the City of Bellevue after the 31st day of December, 1958, at the salary, wage or compensation set forth in the following subsections of this section and as shown opposite the respective position classifications; with the exception of that position preceded by an asterisk (\*), the rate of salary for which will be effective February 1, 1959; and of those positions preceded by two asterisks (\*\*), the salary will be effective January 16, 1959; and of those positions preceded by three asterisks (\*\*\*), the salary will be effective September 16, 1959; to-wit:"

Section 2. Section 2.5 of Ordinance No. 276, as amended by Ordinance No. 283, as amended by Ordinance No. 298 passed on April 28, 1958, as amended by Ordinance No. 308 passed June 23, 1959, is hereby amended to read as follows:

"Section 2.5 Department of Safety:

- Civil Defense Director, per month. . . . . \$ 10.00
- \* Chief of Police, first 6 months of employee's tenure, per month . . . . . 575.00
- Thereafter, per month. . . . . 600.00
- Matron, per month. . . . . 5.00
- \*\*\* Staff Secretary, per month . . . . . 25.00
- \*\*\* Senior Clerk, per month. . . . . 25.00
- Extra monthly pay for the person assigned the duty as head of the Police Department during any vacancy in the position of Chief of Police. . . . . 50.00
- Extra monthly pay for detective and motorcycle officer. . . . . 10.00
- Captain, \$2.21 per hour, with a guaranteed monthly wage of \$500.00.
- Sergeants, \$1.92 per hour, with a guaranteed monthly wage of \$435.00, to \$2.01 per hour with a guaranteed monthly wage of \$455.00.
- Patrolmen, \$1.70 per hour, with a guaranteed monthly wage of \$385.00, to \$1.92 per hour with a guaranteed monthly wage of \$435.00.

Police Woman, \$1.84 per hour, with a guaranteed monthly wage of \$415.00.  
Clerk-Typist, \$1.19 per hour, with a guaranteed monthly wage of \$270.00."

Section 3. This Ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.
