ORDINANCE NO. 3245

AN ORDINANCE creating a series of projects within the General Capital Improvement Program Fund No. 368; specifying the source or sources of funding therefor; and appropriating monies to said Fund.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. There is hereby appropriated to the General Capital Improvement Program Fund No. 368 the sum of \$24,512,000, from the following sources:
