CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3330

AN ORDINANCE increasing the rate of the additional optional sales or use tax upon taxable events within the City; designating the filing officer with whom any petition regarding such increase shall be filed; amending Section 8 of Ordinance No. 1473 and Section 4.12.026 of the Bellevue City Code; and repealing Section 9 of Ordinance No. 1473 and Section 4.12.027 of the Bellevue City Code.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 8 of Ordinance No. 1473 and Bellevue City Code Section 4.12.026, as added by Section 3 of Ordinance No. 3126 and as amended by Section 1 of Ordinance No. 3221, are hereby amended to read as follows:

Section 8. There is hereby added to the Bellevue City Code Chapter 4.12 a new Section 4.12.026, to read as follows:

4.12.026 Additional Sales and Use Tax -- Rate.

The rate of the tax imposed by Section 4.12.025 shall be one-half of one percent of the selling price or value of the article used, as the case may be.

Section 2. The increase in tax imposed by Section 1 of this Ordinance shall be effective within the City of Bellevue on April 1, 1984 and shall remain effective until the last day of the calendar quarter next following thirty days after the date on which the bonds issued pursuant to Ordinance No. 3329 have been fully paid and redeemed; provided, that in the event that on the last day of such calendar quarter there is in effect a sales or use tax imposed by King County pursuant to RCW 82.14.030(2), then the tax imposed by Section 1 of this ordinance shall be reduced effective on the first day of the calendar quarter next following the end of the calendar quarter next following 30 days after the date on which said bonds are fully paid and redeemed to a rate which is equal to the rate of tax then being imposed by King County pursuant to RCW 82.14.030(2), or three tenths of one percent of the selling price or value of the article used, as the case may be, whichever is higher.

Section 3. Section 9 of Ordinance No. 1473 and Bellevue City Code Section 4.12.027, as added by Section 4 of Ordinance No. 3126 and as amended by Section 2 of Ordinance No. 3221, is hereby repealed.


Section 4. Section 4 of Ordinance No. 3221 is hereby repealed.

Section 5. For purposes of Section 2, Chapter 99, Laws of 1983, Regular Session, 48th Legislature of the State of Washington the filing officer with whom a petition concerning the tax increase imposed by this Ordinance must be filed shall be the City Clerk.

Section 6. This ordinance shall take effect and be in force thirty days after the date of its final passage.




