ORDINANCE NO. 3555

AN ORDINANCE authorizing acceptance of a Grant Award Contract with the Urban Arterial Board; creating a new project within Grant Transportation Fund No. 386; appropriating funds received in excess of estimated revenues within Grant Transportation Fund No. 386 and authorizing the expenditure of grant funds and local matching funds for preliminary engineering for the 108th Avenue N.E. project, C.I.P. No. PW-R-21.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized and directed to accept a Grant Award Contract with the Urban Arterial Board in the amount of \$75,000 for the 108th Avenue N.E. project, C.I.P. No. PW-R-21.

Section 2. There shall be established a project within Grant Transportation Fund No. 386 to be known as 108th Avenue N.E. project, C.I.P. No. PW-R-21, in which all of said money shall be deposited.

Section 3. The City Manager or his designee shall have responsibility for the administration of said grant award contract.

Section 4. Upon execution and acceptance of said Grant Award Contract, the budget for Grant Transportation Fund No. 386 shall be and hereby is amended by appropriating revenue received during the current fiscal year in excess of estimated revenues, as a result of the Grant Award Contract herein authorized, to Grant Transportation Fund No. 386 in not more than the following amounts.

<u>Description</u>	<u>Amount Appropriated</u>
108th Avenue N.E. Project (C.I.P. Project No. PW-R-21)	\$ 75,000

Provided, however, that if the actual amount of revenue specified in said Grant Award Contract should be less than the amount provided herein, the amount appropriated herein shall be adjusted to be equal to said lesser amount.

Section 5. The approximate, anticipated sources of revenue for the preliminary engineering phase of the 108th Avenue N.E. project are:

The appropriate administrative officials of the City are authorized to expend UAB funds and City funds in the amount set forth herein for the preliminary engineering phase of the project.

Section 6. This ordinance shall take effect and be in force five days after its passage and legal publication.
