## CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3581

AN ORDINANCE relating to the establishment of a demonstration Residential Permit Parking Zone on various streets in the Surrey Downs neighborhood, with restrictions of two-hour parking except by permit.

WHEREAS, residents in the Surrey Downs neighborhood of the City of Bellevue have complained to the City of on-street parking problems in their neighborhood relating to activities in the adjacent CBD; and

WHEREAS, the City staff has conducted surveys of the Surrey Downs neighborhood to determine the citizens' desires as to the implementation of on-street parking policies; and

WHEREAS, City staff has proposed to the residents of the Surrey Downs neighborhood that a Residential Permit Parking Zone program be implemented on a demonstration basis to determine if parking problems may be reduced or limited; and

WHEREAS, a majority of the residents in the Surrey Downs neighborhood favor the establishment of a demonstration Residential Permit Parking Zone in the Surrey Downs neighborhood; now therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Parking of vehicles on both sides of the streets listed below shall be restricted to two-hour parking from 8 a.m. to 6 p.m. except Saturday, Sunday, and holidays, except by permit issued pursuant to Section 3 of this ordinance:

110th Avenue S.E. from Main Street to S.E. 4th Street  
109th Avenue S.E. from S.E. 1st Street to S.E. 3rd Street  
110th Place S.E. from S.E. 2nd Street to S.E. 3rd Street  
111th Avenue S.E. from S.E. 1st Street to S.E. 3rd Street  
S.E. 2nd Street from 108th Avenue S.E. to 109th Avenue S.E.  
S.E. 2nd Street from 110th Street S.E. to 111th Street S.E.  
S.E. 1st Street from 109th Street S.E. to 110th Street S.E.  
S.E. 1st Street from 111th Street S.E. to 112th Street S.E.  
S.E. 3rd Street from 109th Street S.E. to 110th Street S.E.

Section 2. The parking restrictions established by Section 1 of this ordinance shall not apply to any vehicle parking on the streets enumerated in Section 1 above when said vehicle has a Zone 1 permit sticker or decal issued pursuant to Section 3 herein, attached or affixed on or otherwise directly visible from the front or rear window of the vehicle.

Section 3. Zone 1 permits may be issued by the Department of Public Works to any resident of Surrey Downs residing on any street enumerated in Section 1 herein for each vehicle owned by said resident. Visitor permits will be issued on the basis of one per residence to said residents, with said visitor permits being transferable from one vehicle to another. Said visitor permits may also be borrowed and lent between residents of the Surrey Downs neighborhood. All Zone 1 permits will be issued pursuant to a procedure to be established by the Department of Public Works which shall require proof of residency and vehicle registration prior to issuance.


Section 4. The parking restrictions set forth in this ordinance and the Residential Permit Parking Zone program established hereby shall remain in effect for a period of two years from the effective date of this ordinance, unless modified earlier by Council action, and may be extended by the Council after such two-year period.

Section 5. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.

Section 6. This ordinance shall take effect and be in force thirty days after final passage by the Council.


