

BELLEVUE CITY ORDINANCE NO. 364

AN ORDINANCE establishing job classifications and salaries; and amending Section 2.8 of Ordinance No. 336 and Section 1 of Ordinance No. 356.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 2.8 of Ordinance No. 336, passed by the City Council on January 12, 1960, be and the same is hereby amended to read as follows:

"Section 2.8 Street Department

Street Superintendent	\$ 2.48 per hour, with a guaranteed minimum monthly wage of \$562.00
Heavy Equipment Operator	\$ 2.03 per hour, with a guaranteed minimum monthly wage of \$460.00
Lead Man	\$ 1.76 per hour, with a guaranteed minimum monthly wage of \$398.00 for the first six months of employee's tenure; and thereafter \$1.84 per hour, with a guaranteed minimum monthly wage of \$418.00
Truck Operator	\$ 1.76 per hour, with a guaranteed minimum monthly wage of \$398.00
Light Equipment Operator	\$ 1.81 per hour, with a guaranteed minimum monthly wage of \$410.00
Utilitymen	\$ 1.70 per hour, with a guaranteed minimum monthly wage of \$385.00
Street Laborer	\$ 1.37 per hour, with a guaranteed minimum monthly wage of \$312.00 for the first six months; and thereafter \$1.44 per hour, with a guaranteed minimum monthly wage of \$327.00."

Section 2. Section 2.4 of Ordinance No. 336, as amended by Ordinance No. 356, passed by the City Council on January 26, 1960, be and the same is hereby amended to read as follows:

"Section 2.4 Public Works

City Engineer	\$ 665.00
Office Engineer	567.00
Instrument Man	486.00
Sr. Engineer Aide, first 6 months of employee's tenure	370.00
Thereafter	390.00
Chainmen, first 6 months of employee's tenure	312.00
Thereafter	327.00
Clerk-Secretary	310.00
Extra and Part Time Help	
Engineer (Not to exceed \$2.25 per hour, with monthly limit of \$400.00.	
Labor (Not to exceed \$2.00 per hour, with monthly limit of \$375.00)"	

Section 3. This Ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.
