## CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4072

AN ORDINANCE regarding cutting of trees and vegetation on City property; providing monetary penalties therefor; adding a new section 1.18.045 to Chapter 1.18 of the Bellevue City Code and amending Bellevue City Code 1.18.020.E.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. A new section 1.18.045 is hereby added to Chapter 1.18 of the Bellevue City Code to read as follows:

1.18.045 Monetary Penalty - Trees and Vegetation on City Property - Illegal Clearing, Cutting, Damaging or Removal - BCC 3.43.335

Bellevue City Code 1.18.040.E shall have no application to a violation of Bellevue City Code 3.43.335. Instead, the monetary penalty shall be the greater of:

1. Five hundred dollars for each tree cleared, cut, damaged or removed, or for each act of clearing, cutting, damaging or removing vegetation; or
2. Triple the value of each tree cleared, cut, damaged or removed, or of the vegetation cleared, cut, damaged or removed, the value to be the replacement value as determined under the methods described in the Guide for Establishing Value of Trees and Other Plants, published by International Society of Arboriculture, most current edition.

Section 2. Bellevue City Code 1.18.020E is amended to read as follows:

"Development regulation" means and includes the following, as of or after the effective date of the ordinance codified in this chapter:

1. Bellevue City Code, Title 20 (Land Use Code), Title 22 (Development Code), Title 23 (Construction Code) and Title 24 (Utilities Codes);
2. Bellevue City Code, Chapter 9.11, Anti-Litter Code;

3. City of Bellevue, Department of Public Works Department Standards, as adopted by Resolution No. 5084, as now or hereafter amended.
4. Bellevue City Code 3.43.335, regarding the clearing, cutting, damaging or removal of trees and vegetation on City property.
5. All standards, regulations and procedures adopted pursuant to the above; and
6. The terms and conditions of any permit or approval issued pursuant to the above.

Section 3. This ordinance shall take effect and be in force five days after passage and legal publication.


