CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4129

AN ORDINANCE regarding Panoram Premises; relating to the licensing thereof; repealing Sections 4 and 5 of Ordinance No. 3480, and Bellevue City Code 5.44.030 and 5.44.040; and amending Sections 6, 7 and 8 of Ordinance No. 3480, and Bellevue City Code 5.44.050, 5.44.060 and 5.44.070.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Sections 4 and 5 of Ordinance No. 3480, and Bellevue City Code 5.44.030 and 5.44.040 are hereby repealed.

Section 2. Section 6 of Ordinance No. 3480 and Bellevue City Code 5.44.050 are amended to read as follows:

5.44.050 License Fees - Term - Assignment - Renewals

- A. The license year shall be from January 1st to December 31st of each year. All licenses shall expire on the 31st of December each year. Except as hereinafter provided, all license fees shall be payable on an annual basis. The annual license fee for a Panoram Premises license shall be \$200.
- B. License fees shall not be prorated, except that if the original application for license is made subsequent to June 30th in any year, the license fee for the remainder of that year shall be one-half of the annual license fee. Licenses issued under this chapter may not be assigned or transferred to another operator or premise.
- C. Applications for renewal of licenses issued under this chapter shall be filed with the Clerk on or before the expiration date provided for in this section in the same manner and accompanied by payment of the same fees as are in effect for an original application for that license for the license year applied for. There shall be assessed and collected by the Clerk an additional charge, computed as a percentage of the license fee, on renewal applications not made on or before the license expiration date, as follows:

| Days Past Due | Percent of License Fees |
|---------------|-------------------------|
| 7-30 | 25% |
| 31-60 | 50% |
| 61 and over | 100% |

Section 3. Section 7 of Ordinance No. 3480, as amended by Section 3 of Ordinance 3559, and Bellevue City Code 5.44.060 are amended to read as follows:

5.44.060 License Application - Report by Departments

- A. Any person seeking a Panoram Premises license shall file a written application with the Clerk on a form provided by the Clerk for that purpose. The Clerk, upon presentation of such application and before acting upon the same, shall refer such application to the Police Department, which shall make a full investigation as to the truth of the statements contained therein. The Clerk shall also refer such application to the Design and Development and Fire Departments, and the King County Health Department, which shall investigate and provide information to the Clerk concerning compliance of the premises with this and other applicable City and state health, zoning, building, fire and safety ordinances and laws enforced by the respective departments. The Design and Development, Fire and Health Departments may conduct such physical inspection of the premises as is necessary to determine compliance with such ordinances and laws.
- B. The following information shall accompany each application for a Panoram Premises license:
1. The name, address and telephone number of each person applying for the license.
 2. The name, address and telephone number of each person holding an ownership, leasehold or other interest in the Panoram Premises;
 3. The name, address and telephone number of the manager or other person responsible for the operation of the premises;
 4. The address of the premises;
 5. The number of panoram devices to be located on the premises;
 6. A sketch or drawing sufficient to show the layout of the premises, including all information necessary to determine whether the premises comply with the provisions of this chapter.

Section 4. Section 8 of Ordinance No. 3480, as amended by section 4 of Ordinance No. 3559, and Bellevue City Code 5.44.070 are amended to read as follows:


5.44.070 Inspection of panoram premises.

- A. Applicants for any license authorized to be issued under this chapter shall allow the premises sought to be licensed to be inspected by authorized inspectors from the city fire, police and design and development departments, and the King County health department, for the purpose of determining whether they comply with this chapter.
- B. Licensees operating premises licensed under this chapter shall hold those areas upon the premises which are accessible to the public and the devices therein open for routine regulatory inspections by the city during normal business hours.

Section 5. The ordinance shall take effect and be in force thirty days after passage by the Council.


