ORDINANCE NO. 416

AN ORDINANCE relating to the annexation of a portion of Section 20, Township 24 North, Range 5 East, W.M., upon the petition of Allan H. McDonald and others; and amending Ordinance No. 397.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS;

Section 1. Section 2 of Ordinance No. 397, passed by the City Council on August 23, 1960, is hereby amended to read as follows:

"Section 2. That the boundaries of the territory to be annexed to the City of Bellevue is hereby described as follows:

Beginning in the N.E. $\frac{1}{4}$ of Section 20, Township 24 N, Range 5 E, W.M., King County, Washington, at the intersection of the south city limit line with the west line of the N.P.R.R. right-of-way, thence southerly on said west R.R. right-of-way line into the south $\frac{1}{2}$ of Section 20 to the point of intersection of the right-of-way line with the north line of Lot 12 of Pleasure Point Park unrecorded plat, said North line of Lot 12 being located 636.74' North of, and parallel to the North line of the South $\frac{1}{2}$ of the South East $\frac{1}{4}$ of Section 20, Township 24, N. Range 5 E., W. M., said North line of the South $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 20, Township 24, N. Range 5 East, W.M., having a bearing of North $89^{\circ}48'$ W; thence Westerly along said North line of Lot 12, Pleasure Point Park unrecorded plat to the inner Harbor line of Lake Washington; thence North $1^{\circ}40'$ W. along said inner Harbor line to a point 292.93 North of the North line of said Lot 12, Pleasure Point Park, unrecorded plat; thence North $89^{\circ}12'$ E. a distance of 208 ft.; thence North $0^{\circ}48'$ W. a distance of 50 ft.; thence North $89^{\circ}12'$ E. a distance of 87.08; thence North $36^{\circ}59'44''$ W. a distance of 147.46 ft.; thence North

85°19' W. a distance of 134.7 ft.;
thence South 89°12' W. to the inner
Harbor line of Lake Washington,
thence Northerly, Easterly and
Northeasterly on said Harbor Line
to the Bellevue City Limit line,
as established by Bellevue City
Ordinance No. 223, thence East on
said line to the N.P.R.R. right-
of-way, the point of beginning."

Section 2. This ordinance shall take effect
and be in force five (5) days after its passage, approval and
legal publication.

Section 3. That copies of this ordinance
shall be filed with the Board of County Commissioners of King
County, Washington.
