## CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4201

AN ORDINANCE relating to speed limits; reducing the speed limit on SE Newport Way from 35 miles per hour to 30 miles per hour; providing notification of said proposed change to the Secretary of the Washington State Department of Transportation; and amending Section 2 of Ordinance No. 2538, as amended by Section 1 of Ordinance No. 3410, as amended by Section 1 of Ordinance No. 3425, and as further amended by Section 1 of Ordinance No. 3952.

WHEREAS, a request was made by the Bellevue Police Department that the speed be reduced from 35 miles per hour to 30 miles per hour along SE Newport Way from 128th Avenue SE to approximately 138th Avenue SE (the eastern border of Bellevue's city limits) because the speed limit is inappropriate for the area and the lower speed limit will create a safer environment for pedestrians walking along SE Newport Way; and

WHEREAS, to aid in enforcement and improve safety, King County Department of Public Works has agreed to lower their speed limit on their section of SE Newport Way between 128th Avenue SE and the western edge of Bellevue's city limits at SE 42nd Place from 35 mph to 30 mph; and

WHEREAS, any alternation of maximum limits on state highways within incorporated cities may not become effective until such alternation has been approved by the Secretary of Transportation; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 2538, as amended by Section 1 of Ordinance No. 3410, as amended by Section 1 of Ordinance No. 3425, and as further amended by Section 1 of Ordinance No. 3952 is further amended as follows:

Interstate Highway No. 90, speed limits established as posted by State Department of Highways.


Section 2. The Director of Public Works or his designee is hereby directed to transmit a copy of this ordinance, along with any other necessary documentation, to the Secretary of the Washington State Department of Transportation for approval pursuant to RCW 46.61.415.

Section 3. This ordinance shall be in force and take effect thirty days after final passage by the City Council; provided that the reduction in speed limit for SE Newport Way shall not become effective until the City has received approval of said reduction in speed limit from the Secretary of the State Department of Transportation and appropriate signs giving notice of said reduction in speed limit have been erected.


