#### CITY OF BELLEVUE, WASHINGTON

#### ORDINANCE NO. 4239

AN ORDINANCE establishing speed limits on City streets; adding new sections 11.32.010, 020, 022, 024 and 026 to the Bellevue City Code; and repealing Sections 2 and 3 of Ordinance 2251, as last amended by Ordinance No. 4224 and sections 11.32.030 and 11.32.040 of the Bellevue City Code.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. A new section 11.32.010 is added to the Bellevue City Code to read as follows:

Section 11.32.010 Speed Limits Established - Generally.

The speed limit on all streets shall be 25 miles per hour except those:

- A. Posted as school zones, while the posted limits are in effect:
- B. On which another speed limit is established by the following sections of this chapter.

Section 2. A new section 11.32.020 is added to the Bellevue City Code to read as follows:

Section 11.32.020. The speed limit on the following streets is thirty miles per hour:

Bellevue-Redmond Road from N.E. 8th Street to N.E. 10th Place. Bellevue Way N.E. and S.E. from 108th Avenue S.E. to N.E. 12th Street.

Section 3. A new section 11.32.022 is added to the Bellevue City Code to read as follows:

Section 11.32.022. The speed limit on the following streets is thirty-five miles per hour:

> Bellevue-Redmond Road from 124th Avenue N.E. to 156th Avenue N.E.

Bellevue Way N.E. from N.E. 12th Street to north city limits. Henry Richards Road from Interstate No. 90 to Lake Hills Connector.

Kamber Road from 145th Place S.E. to Henry Richards Road. Lake Hills Connector from S.E. 5th Street to S.E. 8th Street. Northup Way from Bellevue Way N.E. to 132nd Avenue N.E. Northup Way from West Lake Sammamish Parkway N.E. to Bellevue-Redmond Road.

West Lake Sammamish Parkway S.E. and N.E. (SR-901) from the south city limits to the north city limits.

N.E. 8th Street from 124th Avenue N.E. to 156th Avenue N.E.

Bellevue Way S.E. from S.E. 34th Street to 108th Avenue S.E. Lake Hills Connector from S.E. 8th Street to 140th Avenue S.E. 148th Avenue N.E. from N.E. 24th Street to north city limits.

Section 5. A new section 11.32.026 is added to the Bellevue City Code to read as follows:

Section 11.32.026. The speed limits on the following streets are as posted by the Washington State Department of Transportation:

State Route 520. Interstate Highway No. 405. Interstate Highway No. 90.

Section 6. Sections 2 and 3 of Ordinance No. 2251, last amended by Ordinance 4424, and Sections 11.32.030 and 11.32.040 of the Bellevue City Code are hereby repealed.

Section 7. This ordinance shall take effect and be in force five days after its passage and legal publication.
