CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4253

AN ORDINANCE relating to the 1991 Operating Budget; appropriating funds received in excess of estimated revenues; and amending the 1991 Operating Budget adopted pursuant to Ordinance No. 4200 as subsequently amended by ordinances 4236, 4240 and 4245.

WHEREAS, RCW 35A.33.120 permits the City Council to authorize expenditures from funds received in excess of estimated revenues by amendment of the budget; and

WHEREAS, the City Council has increased Storm and Surface Water Utility development fees to a level designed to recover 100% costs associated with providing development services for commercial development and development of environmentally sensitive sites; and

WHEREAS, it is desirable to increase the appropriation to the Storm and Surface Water Utility Fund by appropriating funds received in excess of estimated revenues during the current fiscal year in order to allow the expenditures of the increased development fee revenue in providing service to this group of fee payers; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Amendment of the Storm and Surface Water Utility fund appropriations for the 1991 Operating Budget are summarized as follows:

The details of the budget changes adopted by this ordinance are set forth in that certain document entitled Attachment A, "Budget Detail", which has been given Clerk's Receiving No. 16589.

Section 2. Section 2 of Ordinance No. 4200, the 1991 Budget Ordinance, is hereby amended by appropriating unanticipated revenue received during the current fiscal year to the Storm and Surface Water Utility Fund in the amount set forth in Section 1 of this ordinance.


