ORDINANCE NO. 4254

AN ORDINANCE adopting a new development services fee schedule for the Storm and Surface Water Utility.

WHEREAS, Bellevue City Code 23.76.045 provides for the adoption by the City Council of a standard fee schedule for clearing and grading permits; and

WHEREAS, it is necessary to adopt a new fee schedule for clearing and grading permits to cover current costs of administering said permits; and

WHEREAS, it is also necessary to adopt a fee schedule for providing development services for review of commercial development and for review of development of environmentally sensitive sites in order to meet cost recovery objectives and to increase service delivery; now therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. That certain fee schedule entitled Clear and Grade and Inspection Services: General Fund Land Use, SEPA and Discretionary Review, a copy of which has been given Clerk's Receiving No. 16588 is hereby adopted and shall supersede the previous fee schedule adopted pursuant to Ordinance No. 3981 and given Clerk's Receiving No. 14021. The fees set forth in said fee schedule shall be automatically adjusted on January 1st of 1992 and on January 1st of each succeeding year to reflect any change in the Consumer Price Index (CPI) for the Seattle-Metropolitan area during the immediately preceding year or portion thereof.


Section 2. The fees established hereunder shall apply to all applications filed on or after the effective date of this ordinance.

Section 3. This ordinance shall take effect and be in force five days after its passage and legal publication.




