## CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4351
AN ORDINANCE approving the conditional use permit application of the Bellevue School District for continued use of the Wilburton Instructional Service Center, located at 12241 Main Street.

WHEREAS, Bellevue School District No. 405 has applied to the City for a conditional use permit to allow the continued use of property located at 12241 Main Street and known as the Wilburton Instructional Service Center (WISC), for the Cascade School, data processing, instructional material services, staff training and meeting space for community functions; and

WHEREAS, on February 20, 1992, a public hearing was held thereon by the Hearing Examiner Pro Tempore pursuant to notice required by law; and

WHEREAS, on March 11, 1992, the Hearing Examiner Pro Tempore recommended approval, with condition, of said application and made and entered findings of fact and conclusions based thereon in support of his recommendation; and

WHEREAS, the City Council concurs in the findings of fact and conclusions of the Hearing Examiner; and

WHEREAS, the City of Bellevue has complied with the requirements of the State Environmental Policy Act and the City Environmental Procedures Code; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Council adopts the findings of fact and conclusions made and entered by the Hearing Examiner Pro Tempore in support of his recommendation to the Council in this matter as set forth in "Findings, Conclusions and Recommendation of the Hearing Examiner Pro Tempore for the City of Bellevue, In the Matter of the Application of the Bellevue School District for Approval of a Conditional Use, File No. CUDN 88-4605."

Section 2. The City Council hereby approves the conditional use permit application, with condition, of the Bellevue School District for continued use of the Wilburton Instructional Services Center (WISC) located at 12241 Main Street, and more particularly described in Exhibit A attached hereto and by this reference incorporated herein, for the Cascade School, data processing, instructional material services, staff training and meeting space for community functions, provided this approval is subject to the following condition:

The applicant shall install parking and landscaping per approved plan within 90 days from the date of Conditional Use/Rezone approval. A clearing and grading permit is required for the installation of these improvements. (LUC 20.20.520 and LUC 20.20.590 F.2)

Section 4. This ordinance shall take effect and be in force five days after its passage and legal publication.
