ORDINANCE NO. 441

AN ORDINANCE authorizing the granting of an easement over City of Bellevue property.

WHEREAS the City does own a lot in Belway Addition No. 2, upon which it is contemplated N.E. 12th Street will be eventually constructed; and

WHEREAS King County Water District No. 68 has requested an easement to construct and maintain a water line thereon, now therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The administration is hereby authorized to execute that certain Easement for Water Pipeline, copy of which has been received under Clerk's Receiving number 444.

Section 2. This Ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.

EASEMENT FOR WATER PIPELINE

The GRANTOR does hereby grant to KING COUNTY WATER DISTRICT NO. 68, a municipal corporation, Grantee, its successors and assigns, an easement and right-of-way over, through, under, across, upon and in the following described property:

The North 30 feet of Lot 18, Block 1, in the Plat of Belway Addition No. 2 as recorded in Volume 53 of Plats, Pages 17 and 18, records of King County, Washington,

for the construction, operation, maintenance, repair and/or replacement of water pipeline and appurtenances thereto over the above described property, together with the right of ingress and egress to and from each essement and right-of-way, and all of it, for all purposes necessary and related thereto.

In the event it should become necessary for King County Water District No. 68 to relocate the water mains upon Grantor's property, the same shall be at the sole expense of King County Water District No. 68.

This easement is granted with the understanding that the property affected will be returned to a condition equal to its original condition upon completion of any construction heretofore performed in the area covered by said casement. The Grantee agrees to indemnify and save harmless the Grantor from any liability or damage accruing to the Granter arising from any act or acts of the Grantee.
