ORDINANCE NO. 4515

AN ORDINANCE amending the budget for a number of special purpose funds by appropriating estimated revenues for those funds; and amending Ordinance Nos. 3706, 3800 and 4226.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The budget for Bellevue's special purpose (non-budgetary) funds is hereby amended by appropriating to each such fund estimated revenues for the 1993-1994 period in the amount as indicated in Attachment A "Summary of Appropriation Changes" which is incorporated by reference into this ordinance as if set forth in full herein. The details of the budget amendment for each individual special purpose fund, as adopted by this ordinance, are identified in the individual special purpose fund budget summaries, which have been given Clerk's Receiving No. <u>19025</u>

Section 2. Section 5 of Ordinance No. 3706 is hereby amended to read as follows:

Section 5. Upon execution and acceptance of said Grant Award Contract, the budget for the Urban Arterial Trust Fund shall be and is hereby amended by appropriating revenues received during the current fiscal year in excess of estimated revenues, as a result of the Grant Award Contract herein authorized, to the Urban Arterial Trust Fund in the following amount.

116th Avenue N.E. from N.E. 8th Street to N.E. 12th Street (C.I.P. Project No. PW-R-15) \$343,200

Provided, however, that if the actual amount of revenue specified in said Grant Award Contract should be more or less than the estimated amount provided herein, the amount appropriated herein shall be adjusted to be equal to the amount actually received.

Section 3. Section 5 of Ordinance No. 3800 is hereby amended to read as follows:

Section 5. Upon execution and acceptance of said Urban Arterial Board Accelerated Development Project Agreement for Construction Proposal, the budget for the Urban Arterial Trust Fund shall be and hereby is amended by appropriating revenues received during the current fiscal year in excess of estimated revenues, as a result of the Urban Arterial Board grant funds herein authorized, to the Urban Arterial Trust Fund in the following amount. Urban Arterial Board grant funds for right-of-way acquisition for construction of 108th Avenue N.E./ Northup Way to BNRR (C.I.P. Project No. PW-R-21) \$550,000

Provided, however, that if the actual amount of revenue received from the Urban Arterial Board should be more or less than the estimated amount provided herein, the amount appropriated herein shall be adjusted to be equal to the amount actually received.

Section 4. A new Section 4 is added to Ordinance No. 4226 to read as follows:

Section 4. Upon execution and acceptance of said Transportation Improvement Board Agreement for design, engineering and right-of-way acquisition for 148th Avenue N.E. - N.E. 24th to Bel-Red Road Project, the budget for the Urban Arterial Trust Fund shall be and hereby is amended by appropriating revenues received during the current fiscal year in excess of estimated revenues, as a result of the Transportation Improvement Board grant funds herein authorized, to the Urban Arterial Trust Fund in the following amount.

Transportation Improvement Board Grant Funds for 148th Avenue N.E. -N.E. 24th to Bel-Red Road Project (C.I.P. Project No. PW-R-75) \$541,239

Provided, however, that if the actual amount of revenue received from the Transportation Improvement Board should be more or less than the estimated amount provided herein, the amount appropriated herein shall be adjusted to be equal to the amount actually received.

Section 6. This Ordinance shall take effect and be in force five days after its passage and legal publication.
