CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4652

AN ORDINANCE regarding authorized truck routes; amending Section 1 of Ordinance No. 3596 as last amended by Ordinance No. 4642 and Bellevue City Code 11.70.060; and adding a new Section 11.70.062 to Chapter 11.70.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section I of Ordinance 3596, as last amended by Ordinance No. 4642 and Bellevue City Code 11.70.060 are amended as follows:

11.70.060 Authorized routes - Operation of certain trucks, truck tractors, truck-trailers or truck semitrailer combinations.

It is the purpose of this section to restrict truck traffic in the City of Bellevue to the maximum extent possible to the state highway system or to authorized truck routes, and to prohibit truck traffic on city arterials and streets except where no alternative state highway route or authorized truck route is available. In furtherance of this purpose, all trucks, truck tractors, truck and trailer combinations or truck tractor and semitrailer combinations over eight feet in width, over thirty feet in length, or over thirty-two thousand pounds licensed gross weight, and all vehicles transporting radioactive or hazardous cargo, shall be restricted to the state highway system or to one of the following authorized routes while traveling to and from locations within the city; provided, when such locations are not immediately adjacent to a state highway route or an authorized truck route, vehicles described in this section shall use the shortest and most direct city arterial route between the nearest highway route or authorized truck route and such departure location or destination location, and such vehicles may not use city nonarterial streets except when traveling directly between such locations and the nearest arterial, highway or authorized truck route:

- Route 1 - 148th Avenue between Interstate 90 and State Route 520.
- Route 2 - Bellevue Way between Interstate 90 and State Route 520.
- Route 3 - N.E. 8th Street between Bellevue Way N.E. and 156th Avenue N.E.
- Route 4 - 124th Avenue N.E. between Bel-Red Road and State Route 520.
- Route 5 - N.E. 12th Street/Bel-Red Road between Bellevue Way and 156<sup>th</sup> Avenue N.E.
- Route 6 - Northup Way between Bellevue Way and 148th Avenue N.E.
- Route 7 - 112th Avenue N.E. between N.E. 12th Street and Bellevue Way S.E.
- Route 8 - 156th Avenue N.E. between N.E. 8th Street and Bel-Red Road.

- Route 9 - 116th Avenue/Lake Hills Connector between N.E. 12th Street and S.E. 8th Street.
- Route 10 - Old Bel-Red Road/120th Avenue N.E. between N.E. 8th Street and Northup Way.
- Route 11 - S.E. 8th Street between 112th Avenue S.E. and Lake Hills Connector.
- Route 12 - Forest Drive S.E. between Coal Creek Parkway and its eastern terminus.
- Route 13 - Lakemont Boulevard /164th Avenue S.E. between the north and south city limits.
- Route 14 - N.E. 4th Street between Bellevue Way N.E. and 116th Avenue N.E.
- Route 15 - 112th Avenue/108th Avenue N.E. between N.E. 12th Street and Northup Way.
- Route 16 - S.E. Eastgate Way between Richards Road and 150th Avenue S.E.
- Route 17 - S.E. 36th Street/S.E.38th Street between 128th Avenue S.E. and 150th Avenue S.E.
- Route 18 - S.E. Newport Way/128th Avenue S.E. between Coal Creek Parkway and S.E. Eastgate Way.
- Route 19 - Coal Creek Parkway between I-405 and the south City limits.
- Route 20 - 150th Avenue S.E. between S.E. Eastgate Way and S.E. 38th Street.

Section 2. A new Section 11.70.062 is added to Chapter 11.70 to read as follows:


**11.70.062 Restrictions To Truck Traffic On West Lake Sammamish Parkway**

No person shall operate a vehicle or combination of vehicles and trailers exceeding ten thousand (10,000) pounds gross licensed weight, except authorized buses and solid waste disposal vehicles on West Lake Sammamish Parkway within the city limits of Bellevue unless traveling to or from a destination north of the intersection of S.E. 34th Street and West Lake Sammamish Parkway S.E. and south of the intersection of Bellevue-Redmond Road and West Lake Sammamish Parkway N.E.

Section 3. This ordinance shall take effect and be in force thirty days after final passage by the City Council.




