ORDINANCE NO. 4708

AN ORDINANCE amending the Charter of the Bellevue Convention Center Authority by adding a new subsection F to Section 5.02 of the Charter.

WHEREAS, on December 4, 1989, the City Council adopted Ordinance No. 4092 creating the Bellevue Convention Center Authority and approving the Charter thereof; and

WHEREAS, the City Council desires to amend the Charter as authorized, and in the manner authorized, by Section 5 of Ordinance No. 4092 and Section 9.02 of Ordinance No. 4092; and

WHEREAS, the City Council held a public hearing on the proposed Charter amendment on October 24, 1994; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The Charter of the Bellevue Convention Center Authority, as approved by Ordinance No. 4092, is hereby amended by the addition of a new subsection F of Section 5.02 thereof, a copy of which is attached hereto as Exhibit A, and by this reference incorporated herein.

Exhibit "A"

New Subsection F of Section 5.02 of the Bellevue Convention Center Authority Charter

F. The Authority shall not file or permit to be filed on its behalf a petition for relief under the United States Bankruptcy Code (hereinafter "petition") without first requesting and receiving the written consent of the City Manager. Any such request to the City Manager must be approved by resolution of the Authority adopted in accordance with Section 6.04 of this Charter. The City Manager shall, within 30 days, reply in writing by (i) consenting to the filing of a petition, (ii) consenting to such filing with conditions the City Manager determines appropriate, or (iii) denying consent to the filing of a petition. If the City Manager consents to the filing of a petition, and if the Authority complies with any conditions imposed by the City Manager, the Authority may authorize the filing of a petition by adoption of a resolution in accordance with Section 6.04 of this Charter. If the City Manager denies consent, that action shall be deemed final, and the Authority shall take no further action with regard to the filing of the proposed petition.
