CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4955

AN ORDINANCE adopting an operating budget for the City of Bellevue, Washington, for the 1997-1998 biennium; and setting forth the estimated revenues and appropriations.

WHEREAS, the City Council adopted Ordinance No. 4872 on April 15, 1996 adopting a fiscal biennium budget beginning in 1997, as authorized by chapter 35A.34 RCW;

WHEREAS, a preliminary biennium budget for 1997-1998 was prepared and filed with the City Clerk as required by law; and

WHEREAS, public hearings were held by the City Council on the preliminary biennium budget, at which time comments for or against any part of the preliminary biennium budget were heard; and

WHEREAS, on December 2, 1996, the City Council held a public hearing upon notice as prescribed by law, and met for the purpose of fixing the final budget of the City for the 1997-1998 biennium; and

WHEREAS, the City Council has made adjustments and changes as it deemed necessary or proper and desires to adopt the 1997-1998 biennium budget; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The biennium budget of the City of Bellevue, Washington, for the years 1997-1998, a copy of which has been given Clerk's Receiving No. 23801, is hereby adopted by this reference, in the aggregate total of estimated revenues and appropriations for all funds combined of \$376,344,789.

Section 2. The totals of estimated revenues and appropriations for each separate fund, as set forth herein, are:

Section 3. The job classifications and pay ranges for employees of the City, as set forth in the 1997 Compensation Plan, hereby adopted as part of the biennium budget for 1997-1998, and given Clerk's Receiving No. 23802, shall constitute the job classifications and pay ranges for such employees until changed by the Council.

Section 4. All employees who are members of a bargaining unit shall receive such pay and benefits as are provided for in the appropriate collective bargaining agreement.

Section 5. The provisions of Sections 1, 2, 3, and 4 of this ordinance shall take effect on January 1, 1997.

Section 6. The Clerk is directed to transmit a certified copy of this ordinance to the Office of the Auditor of the State of Washington, Division of Municipal Corporations and to the Association of Washington Cities.



Section 7. This ordinance shall take effect and be in force five (5) days after its passage and legal publication.


