

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 5315

AN ORDINANCE authorizing the City Manager to execute agreements with Washington State Criminal Justice Training Commission and the Eastside Narcotics Task Force to provide staffing and accept funding for staffing; appropriating additional revenues for said services to the General Fund and increasing the General Fund appropriation for the 2001-2002 Budget; and amending the Operating Budget adopted pursuant to Ordinance No. 5266.

WHEREAS, the Washington State Criminal Justice Training Commission (WSCJTC) operates the Basic Law Enforcement Academy that serves all Washington Police Agencies; and

WHEREAS, the Eastside Narcotics Task Force (ENTF) is a coalition of local law enforcement agencies comprised of a King County Prosecutor and officers from Bellevue, Redmond, Kirkland, Mercer Island, and Issaquah, who are responsible for investigating drug trafficking within its jurisdictional boundaries and/or within King County when that activity impacts the Task Force cities; and

WHEREAS, the Washington State Criminal Justice Training Commission (WSCJTC) and the Eastside Narcotics Task Force (ENTF) have determined they need additional staffing resources to address regional needs; and

WHEREAS, both the WSCJTC and the ENTF have requested that the City of Bellevue provide this additional staffing and resources; and

WHEREAS, the WSCJTC has requested that the City of Bellevue temporarily assign an experienced police officer to serve as an instructor at the WSCJTC Academy; and

WHEREAS, the Police Chiefs from the ENTF have requested that Bellevue's drug dog and handler be assigned to the ENTF; and

WHEREAS, the officer assigned to the WSCJTC and the officer assigned to the ENTF will be on temporary assignment for a period of three years; and

WHEREAS, there are multiple benefits to the Bellevue Police Department in providing an officer to serve as an academy instructor and providing a drug dog and handler; and

WHEREAS, the City of Bellevue desires to provide the WSCJTC with an experienced officer to serve as an academy instructor and desires to provide the ENTF with a drug dog and handler; and

WHEREAS, both the WSCJTC and ENTF have agreed to reimburse the City for a 100% of the assigned officer's salary and benefits and other incidental expenses; and

WHEREAS, the revenue from the WSCJTC and the ENTF will allow the City to fund two police officer FTE positions until such time as the agreements with the WSCJTC and ENTF end, keeping the department fully staffed with officers; and

WHEREAS, the Police Department agrees to relinquish two FTE police officer positions at the time the agreements with the WSCJTC and the ENTF end; and

WHEREAS, the City's Operating Budget did not include funding for these purposes; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute agreements with the WSCJTC and ENTF to accept funding for an academy instructor and a drug dog and handler, respectively. Copies of these agreements have been given Clerk's Receiving No. 30805 and No. 30806.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said agreements.

Section 3. The approximate amount and source of revenue for providing officers to the WSCJTC and the ENTF is:

WSCJTC	\$105,172.00
ENTF	\$117,840.00

Section 4. Upon execution of said Agreements, the budget for the Police Department General Fund shall be amended by appropriating to that fund additional revenues in the amount of the additional funding and acceptance herein authorized.

Section 5. The General Fund appropriation for the 2001-2002 Operating Budget, adopted pursuant to Ordinance No.5266, is summarized as follows:

Section 6. Section 2 of Ordinance No.5266, the 2001-2002 Budget Ordinance, is hereby amended by appropriating additional revenue to be received during the current fiscal year to the General Fund in the amount specified in Section 5 of this ordinance. The source of said funds, which were not anticipated in the 2001-2002 General Fund budget, along with the purposes for which they are being appropriated are specified in the agreement referenced in section one of this ordinance.

Section 7. This ordinance shall take effect and be in force five (5) days after its passage and legal publication.
