

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 5402

AN ORDINANCE relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended (Chapter 36.70A RCW); and as adopted pursuant to Chapter 35A.63 RCW, adopting the City's 2002 amendments to the Comprehensive Plan as separately set forth in Ordinance Nos. 5391, 5392, 5393, 5394, 5395, 5396, 5397, 5398, ___x___, ___x___, and 5399.

WHEREAS, the City Council adopted the Comprehensive Plan of the City of Bellevue on December 6, 1993 as required by the Growth Management Act of 1990, as amended, and also adopted the Comprehensive Plan pursuant to Chapter 35A.63 RCW; and

WHEREAS, the Growth Management Act authorizes the City to amend the Comprehensive Plan on an annual basis; and

WHEREAS, the Planning Commission has held public meetings and at least one public hearing on all proposed changes to the Comprehensive Plan and has made certain recommendations to the City Council; and

WHEREAS, the City Council has considered and discussed all proposed annual amendments to the Comprehensive Plan; and

WHEREAS, the City of Bellevue has complied with the requirements of the State Environmental Policy Act and the City Environmental Procedures Code; and

WHEREAS, the City Council desires to amend the Comprehensive Plan consistent with the foregoing; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Council hereby adopts the City's 2002 amendments to the Comprehensive Plan as separately set forth in Ordinance Nos. 5391, 5392, 5393, 5394, 5395, 5396, 5397, 5398, ___x___, ___x___, and 5399. The Comprehensive Plan of the City of Bellevue, as required by the Growth Management Act of 1990, as amended (hereinafter referred to as the "Comprehensive Plan") is amended as set forth in such ordinances.

Section 2. The Comprehensive Plan adopted pursuant to Chapter 35A.63 RCW, is further amended to the same extent and in the same respect as the Comprehensive Plan required by the Growth Management Act of 1990, as amended, is amended consistent with Section 1 of this ordinance and the separate ordinances referenced therein.

Section 3. This ordinance shall take effect and be in force five days after its passage and legal publication. This ordinance and the Comprehensive Plan shall be available for public inspection in the office of the City Clerk.
