

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. <u>5554</u>

AN ORDINANCE adopting the recommendations for the use of 2005 Community Development Block Grant (CDBG) funds as transmitted by the Human Services Commission; authorizing and directing submittal of a proposal to and acceptance of a grant award contract with the United States Department of Housing and Urban Development; creating a new project series within the Operating Grants and Donations Fund; amending the budget for the Operating Grants and Donations Fund by appropriating additional revenues to that Fund; and authorizing the City Manager to enter into contracts with grant subrecipients.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The recommendations from the Bellevue Human Services Commission for the use of 2005 Community Development Block Grant (CDBG) funds, as set forth in the document given Clerk's Receiving No. <u>36735</u>, are hereby adopted.

Section 2. The City Manager or his designee is authorized and directed to submit a proposal to and to execute a grant award contract with the United States Department of Housing and Urban Development for the 2005 Community Development Block Grant (CDBG) Program.

Section 3. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant award contract.

Section 4. There shall be established at the time of execution and acceptance of said grant award, a project series within the Operating Grants and Donations Fund, into which all of said monies shall be deposited.

Section 5. The City Manager or his designated representative shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements with grant subrecipients to implement CDBG-eligible projects and programs in the amount authorized by the City Council.

Section 7. Upon execution and acceptance of said grant award contract the budget for the Operating Grants and Donations Fund shall be amended by appropriating to that fund additional revenues in the amount of the grant proposal and acceptance herein authorized, currently estimated in the following amount:

Section 8. If the actual revenue received from the source specified in said grant award or program income from repaid Home Repair Program loans or other sources should be more or less than the estimated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received. Should the actual grant amount be more, the difference between the actual and estimated amount shall be applied to the Hopelink Employment Program project, up to \$10,000. Should home repair loan repayments received exceed the amount estimated, the additional funds may be used for additional home repair loans.

Section 9. The Finance Director or his designee is authorized to make interfund loans from the appropriate City fund to the Operating Grants and Donations Fund in whatever amounts, for whatever duration and under whatever terms are appropriate and necessary to cover cash flow shortages in the Operating Grants and Donations Fund that may be caused by this grant.

Section 10. The City Clerk is directed to transmit a certified copy of this Ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 11. This ordinance shall take effect and be in force five (5) days after passage and legal publication.

Should the City's actual 2005 CDBG entitlement be greater than the estimate, the additional funds will be added to this program, up to \$10,000.			
I Senior Services	Minor Home Repair Program	\$	60,000	\$.	53,243	Provides low-cost electrical, plumbing, carpentry and disability access repairs to Bellevue homeowners who are low-income, elderly or disabled. This program addresses home repair needs too small to qualify for the City's major Home Repair Program.			
Youth Eastside Services	Expansion & Renovation Project Design	\$	100,000	\$.	-	Funds requested to complete architectural and engineering plans related to the design of an expanded YES Bellevue building. Funding not recommended at this time as \$200,000 in prior year CDBG awards have been invested in the project and future requests for capital construction costs anticipated.
