

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 5556

AN ORDINANCE authorizing and providing for the acquisition of interests in land for the purpose of adding bike lanes and sidewalks on both sides of SE 16<sup>th</sup> Street between 145<sup>th</sup> Avenue SE and 148<sup>th</sup> Avenue SE, burying existing overhead utilities between 143<sup>rd</sup> Avenue SE and 146<sup>th</sup> Avenue SE, improving the intersection at SE 16<sup>th</sup> Street and 145<sup>th</sup> Place SE and widening SE 16<sup>th</sup> Street between 145<sup>th</sup> Place SE and the east entrance to the shopping center on the north side, as a part of CIP Plan No. PW-R-118, SE 16<sup>th</sup> Street Improvements, within the City of Bellevue; providing for condemnation, appropriation, taking and damaging of land and property rights necessary therefore; providing for the cost thereof and directing the initiation of appropriate proceedings in the manner provided by law for said condemnation.

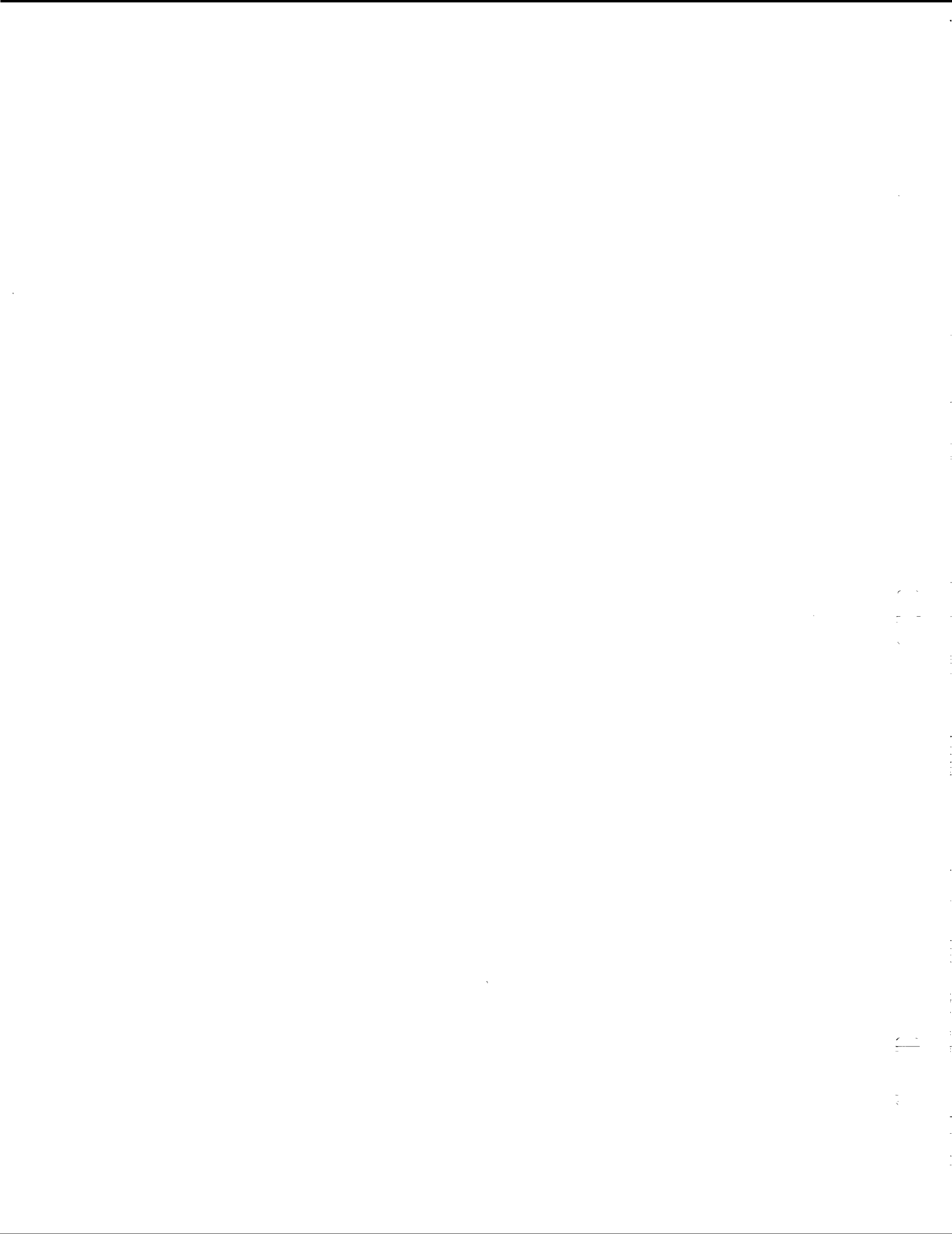
WHEREAS, on December 9, 2002, the City Council adopted the 2003-2009 CIP, which included CIP Plan No. PW-R-118, SE 16<sup>th</sup> Street Improvements, including adding bike lanes and sidewalks on both sides of SE 16<sup>th</sup> Street between 145<sup>th</sup> Avenue SE and 148<sup>th</sup> Avenue SE, burying existing overhead utilities between 143<sup>rd</sup> Avenue SE and 146<sup>th</sup> Avenue SE, improving the intersection at SE 16<sup>th</sup> Street and 145<sup>th</sup> Place SE and widening SE 16<sup>th</sup> Street between 145<sup>th</sup> Place SE and the east entrance to the shopping center on the north side, as a part of CIP Plan No. PW-R-118, SE 16<sup>th</sup> Street Improvements, within the City of Bellevue ("Project"); and

WHEREAS, the City Council has found that the public health, safety, necessity and convenience demand that said Project be undertaken and that in order to carry out the Project it is necessary at this time for the City to acquire interests and rights to the properties described herein; and

WHEREAS, the City Council finds and declares it necessary and in the best interest of the public that interests in the land and property rights hereinafter described be condemned, appropriated, taken and damaged for public use, subject to the making or paying of just compensation to the owners thereof in the manner provided by law; now therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The land and property rights within the City of Bellevue, King County, Washington, described in the attached Exhibit "A", necessary for public road purposes, are hereby condemned, appropriated, taken and damaged for such public purposes, subject to making or paying just compensation to the owners thereof in the manner provided by law.



# ORIGINAL

Section 2. The cost and expense of acquiring said property rights shall be paid for from the Capital Investment Plan No. PW-R-118, SE 16<sup>th</sup> Street Improvements Project, or from other monies the City may have available or may obtain therefore. The Director of the Transportation Department or his designee is hereby authorized to negotiate with and make offers to the owners of said land or property for the purposes of making or paying just compensation, and to approve the payment of just compensation as negotiated with said owners or as ordered by the Court.

Section 3. The City Attorney is hereby authorized and directed to undertake proceedings provided by law to condemn, appropriate, take and damage the land and property necessary to carry out the provisions of this ordinance. The City Attorney is further authorized to approve and enter into any and all such agreements, stipulations, and orders necessary to carry out the provisions of this ordinance, including for the payment of just compensation as agreed to with the property owners, or as ordered by the Court.

Section 4. This ordinance shall take effect and be in force five (5) days after passage and legal publication.

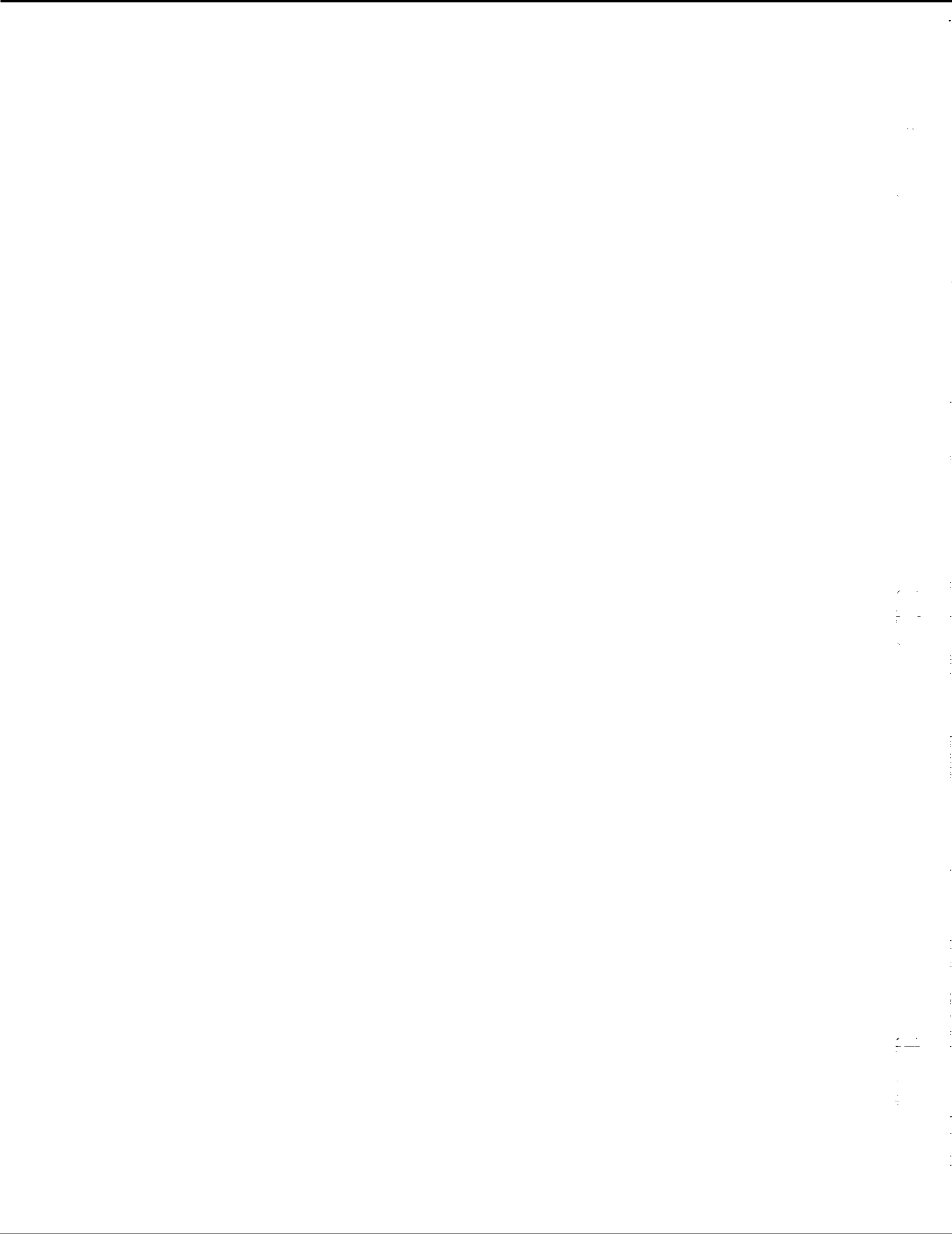
