ORDINANCE NO. 5895

AN ORDINANCE 1) authorizing execution of an Interagency Agreement (and any necessary supplements) with the Washington State Department of Ecology to accept grant funds of up to \$167,447 to retain a consultant to help small businesses prevent pollution and improve related business practices; 2) amending the Operating Grants, Donations, and Special Reserves Fund to increase appropriations by \$167,447; and, 3) authorizing expenditures of said grant funds.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute an Interagency Agreement (and supplements if necessary) with the Washington State Department of Ecology to accept grant funds of up to \$167,447 to retain a consultant to help small businesses prevent pollution and improve related business practices, which Interagency Agreement shall be substantially in the form given Clerk's Receiving No. 44913.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Interagency Agreement.

Section 3. At the time of execution of said Interagency Agreement and acceptance of said funds, a project shall be established within the Operating Grants Donations and Special Reserve Fund into which all said monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof including consultant agreements to expend funds as provided in said Interagency Agreement.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Section 6. Upon execution of said Interagency Agreement the budget for the Operating Grants, Donations, and Special Reserves Fund shall be amended by appropriating revenues in the amount of the grant and acceptance herein authorized.

Provided, however, if the actual revenue received from the anticipated sources specified in said Grant Award should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 8. This ordinance shall take effect and be in force five (5) days after passage and legal publication.




