ORDINANCE NO. 5927

AN ORDINANCE authorizing execution of a Department of Homeland and Security (DHS) Subgrant Agreement (and any necessary supplements) with the Washington State Military Department to accept grant funds in the amount of \$1,109,217 for network resiliency fiber optic cable hardening, BSC fiber optic cable hardening, Eastside Fusion Center analyst, project management/urban area planning sustainment, WebEOC management tool and community preparedness; amending the 2009-2010 budget of the operating Grants, Donations and Special Reserves Fund in the amount of \$1,109,217; and authorizing expenditures from said fund.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute a Subgrant Agreement (and any necessary supplements) with the Washington State Military Department of up to \$1,109,217 for network resiliency fiber optic cable hardening, BSC fiber optic cable hardening. Eastside Fusion Center analyst, project management/urban area planning sustainment; WebEOC management tool and community preparedness, a copy of which Subgrant Agreement has been given Clerk's Receiving No. 45914.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Subgrant Agreement.

Section 3. At the time of execution of said Subgrant Agreement and acceptance of said funds, a project shall be established within the Operating Grants, Donations, and Special Reserves Fund into which all said monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Washington State Military Department

\$1,109,217

Section 6. Upon execution of said Subgrant Agreement, the budget for the Operating Grants, Donations, and Special Reserves Fund shall be amended by appropriating revenue in the amount of the grant and acceptance herein authorized.



Provided, however, if the actual revenue received from the anticipated source specified in said Subgrant Agreement should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 7. This ordinance shall take effect and be in force five (5) days after passage and legal publication.


