ORDINANCE NO. 6015

AN ORDINANCE 1) authorizing execution of a grant agreement (and supplements if necessary) with the Washington State Department of Transportation (WSDOT) to accept a state funded \$355,000 Pedestrian and Bicycle Safety Program grant to enhance pedestrian crossing facilities and access on Northup Way from 156<sup>th</sup> to 164<sup>th</sup> Avenue NE; 2) amending the 2011-2012 general Capital Investment Program (CIP) fund to increase the appropriation by \$355,000; and; 3) amending the 2011-2017 Capital Investment Program (CIP) Plan to increase the budget for the Minor Capital Traffic Operations Program (CIP Plan No. PW-M-2) by \$355,000 and authorizing expenditures from said fund.

## THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

- Section 1. The City Manager or his designee is authorized to execute a grant agreement (and any necessary supplements) with the Washington State Department of Transportation (WSDOT) to accept a state funded \$355,000 Pedestrian and Bicycle Safety Program grant to enhance pedestrian crossing facilities and access on Northup Way from 156<sup>th</sup> to 164<sup>th</sup> Avenue NE, which grant agreement shall be substantially in the form given Clerk's Receiving No. 43612.
- Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant agreements.
- Section 3. The City Manager or his designee is hereby further authorized to execute all documents necessary to fulfill the terms of the agreements authorized in Section 1 and 2.
- Section 4. The City Manager or his designee shall have the responsibility for the administration and expenditure of said grant monies and monies received pursuant to said Agreements and shall have all authority necessary to enter into agreements regarding the use thereof.
- Section 5. The 2011-2012 General (CIP) Fund appropriation adopted by Ordinance No. 5978 on December 6, 2010 as previously amended is hereby further amended to increase the appropriation to said CIP fund by \$355,000.
- Section 6. The City's 2011-2017 General CIP Plan adopted by Ordinance No. 5978 on December 6, 2010 as previously amended is hereby further amending

by increasing the project budget for the Northup Way Pedestrian Crossing Safety Enhancements project (CIP Plan No. PW-M-2) by \$355,000.

Section 7. If the actual revenue received from the anticipated sources specified in said grant agreements shall be more or less than the anticipated amount set forth herein, the appropriations to the CIP Fund and Plan shall be adjusted to be equal to the amount actually received.

Section 8. This ordinance shall take effect and be in force five (5) days after passage and legal publication.
