ORDINANCE NO. 6599

AN ORDINANCE 1) authorizing execution of a grant agreement (and supplements if necessary) with the Washington State Department of Transportation (WSDOT) to accept up to \$1,500,000 in federal National Highway System (NHS) Asset Management Program funding to support the construction of the NE 8th Street Pavement Preservation Project; 2) amending the 2021-2022 General Capital Investment Program (CIP) Fund to increase the appropriation by \$1,500,000; and, 3) amending the 2021-2027 CIP Plan to increase the budget for the Bridge and Pavement Preservation (Overlay) Program (CIP Plan No. PW-M-1) by \$1,500,000.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

| Section 1. The City Manager or his designee is authorized to execute a gran |

- Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant agreement.
- Section 3. The City Manager or his designee shall have responsibility for the administration of said funds and expenditure of said funds received pursuant to said grant agreement and shall have all authority necessary to enter into agreements regarding the use thereof.
- Section 4. The City's 2021-2022 General CIP Fund, adopted by Ordinance No. 6557 on December 14, 2020, as previously amended, is hereby further amended to increase the appropriation by \$1,500,000.
- Section 5. The City's 2021-2027 CIP Plan, adopted by Ordinance No. 6557 on December 14, 2020, as previously amended, is hereby further amended to

increase the budget for the Bridge and Pavement Preservation (Overlay) Program (CIP Plan No. PW-M-1) by \$1,500,000.

Section 6. If the actual revenue received from the Washington State Department of Transportation shall be more or less than the anticipated amount set forth herein, the appropriations to the CIP Fund and Plan shall be adjusted to be equal to the amount actually received.

Section 7. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.
