

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6656

AN ORDINANCE relating to speed limits; amending Section 11.32.015 of the Bellevue City Code to establish a speed limit of 20 miles per hour (mph) on most local streets in a portion of the Eastgate neighborhood surrounding Tyee Middle School.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 11.32.015 of the Bellevue City Code (BCC) is hereby amended to add the following streets:

134th Avenue SE from 125 feet north of SE 37th Street to 520 feet south of SE 37th Street

135th Avenue SE from 136th Place SE to SE 40th Street

135th Avenue SE from SE 37th Street to 500 feet south of SE 37th St

136th Avenue SE from 136th Place SE to SE 40th Street

136th Avenue SE from SE 37th Street to 136th Place SE

136th Place SE from SE 36th Street to 135th Avenue SE

138th Avenue SE from 138th Pl SE to SE Allen Road

138th Place SE from 138th Avenue SE to 139th Avenue SE

SE 38th Street from 140th Avenue SE to 145th Avenue SE  
SE 39th Street from 147th Avenue SE to 148th Avenue SE  
SE 40th Street from 135th Avenue SE to 146th Avenue SE  
SE 40th Street from SE Allen Road to 149th Avenue SE  
SE 41st Street from 142nd Avenue SE to 147th Avenue SE  
SE 42nd Place from 145th Avenue SE to 145th Avenue SE  
SE 42nd Place from 146th Avenue SE to 145th Avenue SE

SE Eastgate Drive from 142nd Place SE to 148th Avenue SE

Section 2. This Ordinance shall take effect and be in force thirty (30) days after its passage and legal publication.
