

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6757

AN ORDINANCE 1) adopting recommendations for the use of 2024 Community Development Block Grant funds as transmitted by the Human Services Commission; 2) authorizing the City Manager or his designee to submit a proposal to the United States Department of Housing and Urban Development (HUD) for the 2024 CDBG Program; 3) authorizing the City Manager or his designee to accept a grant award contract with HUD; 4) and authorizing the City Manager or his designee to enter into agreements with grant subrecipients and contractors.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The recommendations from the City of Bellevue Human Services Commission for the use of 2024 Community Development Block Grant (CDBG) funds, as set forth in the document given Clerk's Receiving No. 80816, and the recommend contingency plan, as set forth in the document given Clerk's Receiving No. 80815, are hereby adopted.

Section 2. The City Manager or his designee is authorized to submit a proposal to the United States Department of Housing and Urban Development (HUD) for the 2024 CDBG Program.

Section 3. The City Manager or his designee is authorized to accept a grant award contract with HUD.

Section 4. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant award contract.

Section 5. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements with grant subrecipients to implement CDBG-eligible projects and programs in the amounts authorized by the City Council in Section One.

Section 6. The estimated amount and anticipated source of revenue for the grant proposal and acceptance is:

2024 Estimated CDBG Entitlement:	\$850,000
Prior Year Unspent Funds	\$299,000
2024 Estimated Program Income:	<u>\$150,000</u>
Total Estimated 2024 Funds:	\$1,299,000

Section 7. Upon execution and acceptance of said grant award contract, the budget for the Operating Grants and Donations Fund shall be amended by appropriating to that fund additional revenues in the amount of the grant proposal and acceptance herein authorized, currently estimated in the following amount:

Operating Grants and Donations Fund <i>2024 CDBG Program</i>	\$1,299,000

Provided, however, if the actual revenue received from the source specified in said grant award or program income from repaid Home Repair Program loans or other sources should be more or less than the estimated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received. Expenditure of any amounts more or less than the estimated amounts shall be made in accordance with the recommendations adopted in Section One and allowing that any home repair loan repayments received in excess of the amount estimated may be used for additional home repair loans.

Section 8. The Director of Finance and Asset Management or her designee is authorized to make interfund loans from the appropriate City fund to the Operating Grants and Donations Fund in whatever amounts, for whatever duration and under whatever terms are appropriate and necessary to cover cash flow shortages in the Operating Grants and Donations Fund that may be caused by this grant.

Section 9. The City Clerk is directed to transmit a certified copy of this Ordinance to the Auditor of the State of Washington, Division of Municipal Corporations, and to the Association of Washington Cities.

Section 10. This Ordinance shall take effect and be in force five days (5) after its passage and legal publication.
