ORDINANCE NO. 82

AN ORDINANCE repealing Section 1 of Ordinance No. 74, Section 1 of Ordinance No. 26, all of Ordinance No. 65 and amending Section 5 of Ordinance No. 50 and establishing and re-establishing salaries for certain city employees.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. The administrative officers, agents and employees of the City of Bellevue, hereinafter listed, shall be compensated for service rendered to the City of Bellevue after the 31st day of December, 1954 at the salary or salaries set forth following the respective job classifications to-wit:

Section 2. The hourly wages or monthly salaries or any classification of administrative officer, agent or employee not listed in Section 1 above shall continue at hourly or other wage rates heretofore set by ordinance.

Section 3. The wages or salaries of the city employees, agents or officers where compensation has been set by ordinance shall be paid monthly or at such more frequent period as the City Manager may determine, following rendition of such service to the city.

Section 4. Section 1 of Ordinance No. 74, Section 1 of Ordinance No. 26 and all of Ordinance No. 65 be, and hereby are, repealed. Section 5 of Ordinance No. 50 is amended as to that portion thereof setting the municipal court's salary.

Section 5. This ordinance shall be in force and effect on the First day of January, 1955.
