

ORDINANCE NO. 84

AN ORDINANCE annexing a portion of the West half of the Northeast quarter of Section 20, Township 25 North, Range 5 East, W. M. to the City of Bellevue upon petition of Nelson and Whipple.

WHEREAS, a written petition was filed with the City Council of the City of Bellevue for the annexation of the territory herein described, and

WHEREAS, the City Council has examined the petition and has found, upon satisfactory proof, that the petition was signed by the owners of not less than 75% in value, according to the assessed valuation for general taxation of the property therein described, and in all respects has met the requirements of Chapter 128, Laws of 1945 of the State of Washington, and

WHEREAS, the City Council fixed the 21st day of December, 1954 as the date for public hearing thereon and caused notice of such hearing to be published in accordance with the law, and the hearing having been held on said date; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. That the proposed annexation of territory to the City of Bellevue will be conducive to the public health, welfare and convenience of the City of Bellevue and will be of special benefit to the land included within the boundaries of the territory proposed to be annexed.

Section 2. That the boundaries of the territory to be annexed to the City of Bellevue are hereby described as follows:

Beginning at the intersection of the centerline of N.E. Northrup Way with the west line of the N.E. quarter of Section 20 T.25 N R 5 EWM; thence northerly along said quarter section line to the southwesterly extension of the northwesterly right of way line of N.E. 38th St.; thence northeasterly along said northwesterly line to the southwesterly right of way line of the Northern Pacific Railway Company; thence southeasterly along said southwesterly line to a point on a 6°00' curve, (PC=507 + 68.6 N.P.R.R. stationing) which is the intersection of a line which bears S 34°38' W, 609.4' more or less to the northeasterly right of way line of County Road 85, said bearing is in reference to the west line of the N.E. $\frac{1}{4}$ S 20 T 25N R 5EWM; thence S 34°38' W, 609.4' more or less; thence N 71°54' W, 253.10' more or less, thence S 00°18' 24" W to the center line of N.E. Northrup Way; thence northwesterly along said centerline to the point of beginning.

Section 3. That the above described territory shall become a part of the City of Bellevue on the 28th day of December, 1954, and become subject to all of its laws and ordinances then and thereafter in force.

Section 4. That copies of this ordinance shall be filed with the Board of County Commissioners of King County, Washington.
