

AN ORDINANCE amending Section 112 of Chapter XI of Ordinance No. 27, adopted July 21, 1953, by adding thereto a new section providing for certificates of inspection and safety.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO ORDAIN AS FOLLOWS:

Section 1. Section 112 of Chapter XI of Ordinance No. 27, adopted the 21st day of July, 1953, is amended so that as amended said section will read as follows:

Inspection of Bicycles. The Chief of Police or "Section 112c. an officer or other agent of the City to whom the Chief shall assign such responsibility, shall inspect each bicycle before licensing the same and shall refuse a license for any bicycle which he determines to be in an unsafe mechanical condition; provided, however, that whenever any applicant for a bicycle license shall reside at a point more than one-half mile distant from the bicycle inspection station (as designated by the Chief of Police hereunder), or whenever street or traffic conditions render the riding or transportation of such bicycle, to the inspection station, difficult or dangerous, the Chief of Police may authorize the issuance of such license, without inspection, upon submission of an application therefor which shall be signed by the owner of the bicycle, if such owner be over 16 years of age, or by the person in loco parentis to a bicycle owner under 16 years of age. When application is made for the issuance of a bicycle license without an inspection at an approved inspection station, the applicant shall certify that

- (1) Such bicycle is equipped as required by Section 118 hereof.
- (2) Such bicycle has been inspected and that the chain and sprockets have been recently cleaned, lubricated and found not to be so worn or defective as to create a danger to the rider from slipping or breaking.
- (3) That all nuts, bolts and locknuts locking or holding the handle-bars, seat, axles, brake linkage, controls and other accessories are in good shape and securely tightened.
- (4) That said bicycle is equipped with a red reflector on the rear fender together with such light reflective strips affixed to other portions of the bicycle in the manner required by the Chief of Police.
- (5) That the coasting mechanism and the brake or brakes are in good working condition and are without known defects; that the same have been cleaned, inspected and serviced within months of such certificate.

and furnish the date or dates of the inspections or services mentioned in such certificate.

"Provided further that such inspection or owners certificate shall not be required for a new bicycle when application for such license

is made within three (3) months of the original sale thereof. "

Section 2. This ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.

No person shall operate a bicycle unless it is equipped with a bell or other device capable of giving a signal audible for a distance of at least 200 feet, except that a bicycle shall not be equipped with, nor shall any persons use upon a bicycle, any siren or whistle. No bicycle shall be operated after sundown unless equipped with suitable head and tail lights or flashers.
