RESOLUTION NO. 1030

A RESOLUTION regarding the annexation of contiguous unincorporated territory, including Sherwood Forest.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Council does hereby determine that the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

Portions of Sections 23, 26 and 27, Twp. 25 N., R. 5E., W.M. described as follows:

Beg. at the intersection of a Line 42' South of the S. line of the N_2^1 , of the N_2^1 of Sec. 27, said Twp. & Range, with the W. line of said Sec. 27; thence easterly along said line and parallel with the S. line of the N_2^1 of the N_2^1 of Sec. 27, to the centerline of 148th Ave. N.E.; thence southerly along said centerline to the South margin of County Road No. 966;

Thence northeasterly and easterly along said south margin to the east line of the W_2 of the W_2 Sec. 26, Twp. 25 N., R. 5 E., W.M.; thence northerly to the south line of the N_2 of the N_2 of said Sec. 26;

Thence easterly along said line to the centerline of the Bellevue-Redmond Road; thence northeasterly along said centerline to the E-W Center line of Sec. 23, Twp. 25 N., R. 5 E., W.M.; thence easterly along said centerline to the east line of said Sec. 23; thence southerly along said line to the N.E. corner of Sec. 26 said Twp. and Range; thence continuing southerly along the east line of said Sec. to the East-West centerline thereof; thence westerly along said centerline to the east line of the W¹₂ of the W¹₂ of said Sec.;

Thence southerly along said line to the north line of the S_{2}^{1} of the S_{2}^{1} of the S_{2}^{1} of said Sec.; thence westerly along said north line to the west line of Sec. 27, thence northerly to the point of beginning.

Situate in King County, Washington.

Section 2. That, as nearly as may be, the number of voters residing in the aforesaid territory is 487.
