

RESOLUTION NO. 1218

A RESOLUTION in regard to L.I.D. No. 62-S-29, for the improvement of N.E. 6th Street from 104th Avenue N.E. to 106th Avenue N.E.; and authorizing payment of final draw to contractor and also miscellaneous expenses.

WHEREAS the City Council did on August 3, 1965, pass Ordinance No. 771, thereafter amended by Ordinance No. 803, for the improvement of N.E. 6th Street from 104th Avenue N.E. to 106th Avenue N.E., by paving and otherwise improving the same, and did create Local Improvement District No. 62-S-29 therefor; and

WHEREAS said project has progressed and L.I.D. revenue warrants have previously been issued as follows:

Warrant No. 1, dated December 17, 1965 \$4,480.28

AND WHEREAS a contract has been let for the construction of the above-entitled public works project, and the City Engineer has, in writing and under date of March 11, 1966, approved and recommended payment to Bellevue Bulldozing, Inc. of the sum of \$1,132.26; and

AND WHEREAS it is necessary to issue L.I.D. warrants in payment thereof;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Bellevue that the administrative personnel and proper officials, for and on behalf of the City of Bellevue, Washington, proceed with the issuance of local improvement district warrants in the amount of Two Thousand Nine Hundred Sixty-four and 02/100 (\$2,964.02) to bear interest in accordance with the bid and contract of Statewide City Employees Retirement System, contract purchaser of the warrants and bonds in the financing of said project.
